

MINUTES OF THE MEETING  
TAXATION COMMITTEE  
MONTANA STATE SENATE

February 17, 1979

The thirtieth meeting of the committee was held on the above date in Room 415 of the State Capitol Building, Chairman Turnage presiding.

ROLL CALL: Roll call found all members present with the exception of Senators Brown and Roskie. Witnesses giving testimony are listed on attached Register.

CONSIDERATION OF SENATE BILL 481: Senator Regan presented her bill which she said would provide that justices, judges, court reporters would receive standard state travel expenses for work-related travel. She said the problem had been discovered in Finance and Claims Committee concerning the per diem of those justices, judges, court reporters. She said there was also new language she wished to be included in the bill, concerning reinsertion of words, "actual and necessary" and following her testimony, obtained such amendments. The Chairman called for additional proponents or opponents, and following, for questions from the committee. Mr. Abley answered several committee questions saying the amendment to the law was thought necessary as the people referred to should receive same per diem as other state employees.

Following the brief questioning, the hearing on SB481 was closed until such time as the proposed amendments could be obtained, Exh. #1.

CONSIDERATION OF SENATE BILL 477: Senator Hager introduced his bill and said it had been introduced at the request of the Inheritance Tax Division of the Department of Revenue. He then turned the remainder of the time for introduction of the bill to Mr. Pilon who explained some of the difficulties the state now has in collecting unclaimed property. He went through the bill and pointed out how the statutes govern the disposition of unclaimed property. The bill allows intangible interests in a business that is to be presumed abandoned, and subject to the present statutes.

Dennis Dunphy of the Attorney General's office also spoke in regard to the bill which he termed was a Uniform Act. He suggested suggested an amendment, see Exh. #2, attached. The amendment was adopted by the committee:

Sen. Towe Moved to Adopt Amendments, Exh. #2. The motion carried.

Senator Towe proposed another amendment: page 2, line 15, strike "neither" insert "not" and also on line 16, page 2, after "(1)" stike remainder of lines 16, 17, 18, 19, 20 and 21, and reletter subsequent subsections. This Amendment was Moved by Senator Towe and the Motion Carried.

The committee asked a number of questions as there were no other proponents or opponents, and it was learned that the proceeds from the sale of unclaimed properties goes into the state's foundation program for the schools and approximately \$130,000 to \$200,000 goes into the program yearly.

Another amendment was proposed by Senator Towe: page 7, after line 24. "Securities which have little or no value may be held by the Department of Revenue and sold at its discretion as provided in this section." This Amendment was Moved by Senator Towe. Motion was carried. Note for record a "No" vote was cast by Senator Manley.

Members discussed also putting the administration of this division into the Department of Revenue rather than with the Attorney Generals office. Following a general discussion, the hearing on SB477 was closed.

The members then had the amendments for SB481 for their further consideration. The amendments, see Committee Report attached, were discussed and adopted.

Senator Towe then Moved SB481, As Amended, Do Pass. The motion carried unanimously.

Senator Manley then Moved SB415, As Amended, Do Pass. The motion carried unanimously. The amendments had been adopted February 16.


Senator Hager Moved SB222 Do Not Pass. The motion carried unanimously.
