FISH AND GAME COMMITTEE

MONTANA STATE SENATE

February 17, 1979

The thirteenth meeting of the Fish and Game Committee was called to order by Chairman Smith at 12:30 P.M., in Room 402 of the State Capitol Building.

ROLL CALL: All members were present.

CONSIDERATION OF SENATE BILL 497, A BILL FOR AN ACT ENTITLED: "AN ACT PROVIDING FOR A PERMIT SYSTEM FOR THE AERIAL HUNTING OF PREDATORY ANIMALS; FORBIDDING THE HARASSMENT OF LIVESTOCK BY AIRCRAFT; PROVIDING PENALTIES, INCLUDING FORFEITURE OF PERSONAL PROPERTY, FOR ILLEGAL AERIAL HUNTING OF WILDLIFE; AND PROVIDING AN IMMEDIATE EFFECTIVE DATE."

Chairman Smith asked Senator Van Valkenburg, Chief Sponsor, to explain it. Senator Van Valkenburg said there had been considerable aerial hunting in his district and his constituents had requested that he prepare and present the bill. He went on to say there seem to be no regulations in the area regarding aerial predatory hunting. He then asked Mr. Charles Brown, Attorney for the Department of Livestock, to present his testimony. Mr. Brown, proponent of the bill, stated the bill is necessary because of the extensive losses caused by predators.

Mr. Joe Helle, a rancher, stated that, because of predators, the sheep industry has suffered greatly; therefore, he would support the bill, as amended.

Mr. Jerry Devlin, a sheep rancher from Prairie County, said that, because of the permitted pilots, there had been a noticeable loss of predators, and he would support the bill with the addition of the amendments.

Mr. McKamey, a rancher, spoke in support of the bill, saying he would ask that it pass with the amendments.

Mr. Chuck Newsom spoke in favor of the bill.

Chairman Smith asked for proponents; Mr. Hank Fischer, representing "Defenders of Wildlife," testified, stating he did not think this bill would be fair to the wildlife populations of Montana. It is his feeling the bill needs some changes.

Ms. Jean Curry, representing "Friends of the Earth," confronted the Committee with her suggestions to strengthen the bill. She also said nonresident hunters should not be allowed. (Attachment #2)

Mr. Bill Rogers, who is an aerial hunter representing himself and his family, said he has flown aircraft for many years, and he is opposed to the fact that confiscation of planes could occur as a result of this bill and cause less interest in the killing of coyotes.

Mr. Ralph Wright of Billings also spoke regarding the fact that aerial hunting would be reduced.

When Chairman Smith asked for comments from the Committee, Senator Van Valkenburg said that no matter what bill comes out, there would be problems with it. He further stated that, as amended, he would urge passage of the bill.

Senator Manley stated this is a horrible piece of legislation, in his opinion. He felt the bill is just another step toward taking citizens' rights away.

Chairman Smith mentioned that no one's testimony would be ignored. He said all information should be based on facts, and he is certainly aware that predation has been a serious problem.

Senator Goodover said although he is not involved in aerial flying, he is interested in hearing both sides come up with good arguments. He asked whether or not there is any common meeting ground.

Mr. Norton Minor said that because of Judge Battin's ruling, some kind of legislation should be passed.

Mr. Les Graham, representing the Department of Livestock, said there are no problems. He stated they have documented all flying time and the number of hours flown by permitted pilots; all records are very accurate.

The discussion was finished, and Chairman Smith closed the hearing on SB 497.

DISCUSSION OF SB 470, A BILL FOR AN ACT ENTITLED:
"AN ACT TO PROVIDE FOR PUBLIC FINANCING OF POLITICAL CAMPAIGNS FOR THE OFFICE OF STATE SENATOR AND TO PLACE LIMITS ON THE EXPENDITURES OF CANDIDATES ACCEPTING MONEY FROM THE PUBLIC CAMPAIGN FUND FOR STATE SENATE CAMPAIGNS."

Senator Towe stated, as sponsor of this bill, it had nothing to do with predators, but while campaigning, he did kill a coyote with his car.

He said SB 470 has to do with the amount of money spent on campaign funds. He said that, although his own campaign was found to have been most expensive, it had no bearing on his presenting this bill.

Mr. Jim Minor, representing "Common Cause," had been an unsuccessful candidate and testified regarding funding of campaigns.

Chairman Smith found it necessary to limit the testimony due to the short length of time before the session was to begin. Senator Anderson commented that this is a beautiful bill for an incumbent. Chairman Smith closed the hearing on SB 470.

CONSIDERATION OF SB 485, A BILL FOR AN ACT ENTITLED:
"AN ACT TO EXEMPT LICENSED ATTORNEYS FROM THE REAL ESTATE LICENSE ACT OF 1963."

Senator Richard Smith, Chief Sponsor, explained that this is merely a housekeeping bill.

Mr. Tom Honzel, an attorney representing the Montana Association of Realtors, spoke as an opponent, saying the bill is not needed. Mr. Cliff Christian, representing the same association, spoke in opposition to the bill, stating people generally require the services of an attorney when selling land or homes.

Chairman Smith closed the hearing and asked for questions from the Committee. Senator Galt said he would vote for the bill if it were amended.

DISPOSITION OF SB 485: Senator Galt made a motion that SB 485 DO NOT PASS. The motion was seconded by Senator Goodover. Following a roll call vote, the motion carried 5-2, with Senators Van Valkenburg and Anderson voting "no."

CONSIDERATION OF SB 488: A BILL FOR AN ACT ENTITLED:
"AN ACT TO REQUIRE THE ADMINISTRATIVE CODE COMMITTEE TO

REVIEW, DURING THE NEXT FOUR BIENNIUMS, RULES ADOPTED BY CERTAIN STATE AGENCIES SUBJECT TO APPROVAL BY THE LEGISLATURE, RULES TO BE CONTINUED OR INVALIDATED."

Senator Greg Jergeson, Chief Sponsor, explained that this legislation is to require the Administrative Code Committee to review rules adopted by certain state agencies.

There being no proponents or opponents, Chairman Smith asked for questions from the Committee.

DISPOSITION OF SB 488: Senator Van Valkenburg made a motion that SB 488 DO PASS AND BE PLACED ON THE CONSENT CALENDAR. The motion carried unanimously by a voice vote.

CONSIDERATION OF SB 461, A BILL FOR AN ACT ENTITLED: "AN ACT TO GENERALLY REVISE THE APPOINTMENT PROCEDURES AND DUTIES FOR CITY ATTORNEYS."

Senator Steve Brown, Chief Sponsor of the bill, explained this legislation would revise appointment procedures for and duties of city attorneys. After some discussion, it was decided the bill would benefit small towns, as well as the larger cities.

DISPOSITION OF SB 461: Senator Manley made a motion that SB 461 DO PASS. Senator Goodover seconded the motion and it carried unanimously by a voice vote.

CONSIDERATION OF SB 501, A BILL FOR AN ACT ENTITLED: "AN ACT REQUIRING TRAPPERS TO FILE MAPS OF THEIR TRAPLINES WITH THE DEPARTMENT OF FISH AND GAME AND MAKING TRAPPERS STRICTLY LIABLE FOR ALL DAMAGE DONE TO LIVESTOCK."

Senator Mark Etchart, Chief Sponsor of the bill, explained it. He asked if Mr. Wayne Putts, who is very familiar with snares, could testify in regard to the bill. Permission to do this was granted, and Mr. Putts produced pictures of animals that had been caught in snares, causing such injuries that cattle buyers would only consider buying the animals for dog food. He also mentioned that horseback riders have been thrown from their horses when the animals are caught in these snares. A snare was passed around the Committee for examination.

DISPOSITION OF SB 501: Proposed amendments were discussed. (Please refer to Standing Committee Report.) Senator Manley made a motion that SB 501, AS AMENDED, DO PASS.

The motion carried unanimously by a voice vote.

CONSIDERATION OF SB 504, A BILL FOR AN ACT ENTITLED:
"AN ACT TO MAKE IT A MISDEMEANOR TO LEAVE SNARES AND TRAPS UN-
ATTENDED AND TO WASTE FURS OR FUR-BEARING ANIMALS."

Senator Robert Watt, Chief Sponsor, explained the bill. Following discussion it was decided to amend the bill by removing the word "furs." Mr. Erv Kent, Administrator of the Law Enforcement Division, Department of Fish and Game, stated the Department supported the bill.

DISPOSITION OF SB 504: Senator Van Valkenburg made a motion that SB 504, AS AMENDED, DO PASS. The motion carried unanimously, following a voice vote.

ANNOUNCEMENTS: Chairman Smith announced the Committee would meet on adjournment of the session today to discuss SB 497 and to consider SB 470, SB 440, and SB 475.

ADJOURNMENT: Chairman Smith adjourned the meeting at 12:30 P.M.

SB 497 testimony
Feb. 17, 1979

My name is Jean Curry. I am the Montana Representative for Friends of the Earth, which is an organization surprisingly reflects the Conservation of Montanans in general. Our organization recognizes the need to be adaptive to regionalism rather than exploitative of an area and that conservative and fiscally prudent approaches to resource management make the most sense for the long term stability of earth communities.

Our members in Montana are both new and native to the state. My daughter is a 4th generation Montanan from the Deer Lodge valley. Her grandfather has told me in many discussions over coffee at the ranch about his concerns for ~~the~~ the modern & insensitive control of predators.

I have been actively involved in both trying to understand and alter predator policy in Montana. I continue to be confused, frustrated & overwhelmed by what appears to be policy based on myth, speculation, greed, and unscientific assumptions. Montana's predator policy makers tend to dismiss the need for objective, scientific data. What if we tried to implement a

SB 497 is basically a good attempt
 to effectuate control over aerial hunting,
 but as written it is excessively general,
 full of loopholes and will perpetuate
 unwise wildlife management without
 necessarily meeting a goal of livestock
 protection.

I would like to offer the following
 suggestions to strengthen this bill:

1. That, at a minimum, all of the
 recommendations made by Hank Fisher
 of Defenders of Wildlife be incorporated
 as amendments to SB 497
2. That predation of game animals be
 deleted from this bill; it is highly
 inappropriate for the Dept. of Livestock
 to be in the business of "protecting"
 game animals from predation.
3. That "potential" livestock losses
 be deleted as a legitimate reason for
 a permit. "Potential" is just far too
 easily abused.

but the wildlife is a public resource
 and... landowners should not be exempt
 from this permit program. There needs to
 be some way to keep the predator kill counts.

5. That Sec. 3 includes wildlife along with livestock regarding prohibition of harassment.
6. That out of state or non-resident hunters not be allowed to exploit the program.
7. That the money generated be enough to properly and fairly enforce the program.
8. That permits be issued for only one year.
9. That a strict qualification ^{be included} requiring permittees to demonstrate knowledge of and ability to distinguish endangered or threatened species.
10. A strict, standardized criteria for issuing permits that eliminates discretion of Livestock Dept. personnel.

If these very reasonable amendments are not incorporated into SB497, we would have to withdraw any support of the bill.

TESTIMONY OF FIVE VALLEYS AUDUBON & Montana Audubon Council
concerning SB 497

The Five Valleys Audubon Chapter serves a 4 county area of Western Montana. Our chapter which was formed two years ago now has approximately 400 members. The rapid rate of growth in the size of our chapter along with the formation of other new Audubon chapters in the state of Montana are we feel an indication of the interest among Montanans in non-game wildlife.

We are very disturbed with Judge Battin's ruling. And I as a law student would judge from the precedent existing previous to the case that the decision will not stand. We feel that it is appropriate for Montana to act immediately to control aerial hunting within Montana. We are concerned for the impacts that aerial hunting unregulated will have on our game and non-game animals. Aerial hunting must be controlled strictly in relation to game and non-game animals. No individual should be allowed to feel that he has license to decimate populations of valued animals. We are specifically concerned for the large birds of prey and the rarer mammals.

Unfortunately, this bill from our perspective is very inadequate in protecting the game and non-game animals of the state. We feel that Montana can by drafting and adopting a tough bill present to the other states and the Federal government an effective model for legislation in this area.
