

MINUTES OF THE MEETING

PUBLIC HEALTH, WELFARE & SAFETY COMMITTEE

March 7, 1979

The twenty-second meeting of the Senate Public Health, Welfare and Safety Committee met in Room 410 of the State Capitol Building at 1:00 p.m. on March 7, 1979.

ROLL CALL: All Committee members were present except Senator Rasmussen and Senator Himsl. Senator Rasmussen arrived later in the meeting.

CONSIDERATION OF HOUSE BILL 233: House Bill 233 is an act to permit the Board of Dentists to establish examination standards and procedures and to establish examination, license, renewal, and reinstatement fees for dentists and dental hygienists commensurate with costs or within certain limits.

Representative Bennett, sponsor of House Bill 233, said he was asked by the dentists to sponsor the bill. The bill in Section 1, subsection 3, provides for members of the faculty and students who are actually performing dental procedures to be excluded from having to have a license to practice dentistry in the state of Montana. The change on page 3 is made because there has been some trouble setting up the examinations in the state of Montana. This is so they can recognize the national board and the regional board. The regional board will be given in Salt Lake where they have the facilities. The bill still reserves the right to give examinations in Montana. On page 7 is the annual renewal fee, which is left up to the discretion of the board, but not to exceed \$50. The board wants to maintain their emergency fund of \$2500 so that they can properly examine and carry out the duties of policing their profession; and this fund is a little low now. It also creates a method whereby they charge \$10 for a late renewal instead of the present \$3. It does about the same thing for the dental hygienist and sets up a fee of \$25.

Dr. Douglas Wood, Board of Dentists, said that the thing that really brought about a need for this bill is the increased cost and the difficulty in administering the examination. A larger group comes in each year, and the facilities aren't really available. We were incurring costs in moving equipment and storing equipment. The examination wasn't in that sense totally fair because of the difference in equipment. The board is incurring more costs in disciplinary actions. The neighboring states have joined in a regional exam, and the exam is a little more extensive than the one Montana gives. Anytime the exam is given at least one Montana board member would be present. Also, it increases the maximum amount for relicensure fee because the board has had a problem staying within the monies that it has generated.

Irving Dayton, Montana University System, spoke in support of the amendment on page 2 which opens up the possibility of giving dental students some practical experience. They have been looking into a couple of programs with the goal of putting students out into the under-served areas in the state to get some practical experience. This amendment will open up that possibility.

Fred Stout, Montana Dental Association, said he was here to testify in support of House Bills 233, 234 and 585. See Attachment "A."

JoAnne Karr, Carroll College, spoke in support of House Bill 233 because of the amendment in paragraph 3 which would enable them to provide a more active academic program for their dental hygiene students. See Attachment "B."

Dr. John Lohman, Montana Dental Association, spoke in support of House Bill 233. See Attachment "C."

Chairman Olson asked the Committee members if they have any questions. Senator Norman asked how many dentists are licensed in Montana. Representative Bennett said there are about 400 licensees who practice in the state, and about 900 who are licensed. They license about 35 to 40 new ones a year, and about one-half of those practice in the state. Senator Lensink verified that the Board of Dentists licenses dental hygienists. Senator Ryan questioned putting in a fixed dollar amount that can be charged for licenses. He said that the way the bill is written that in two years the board is probably going to be back and want the law changed to raise the fees. Chairman Olson asked Dr. Wood if Montana has reciprocity with other states. Dr. Wood said not at the present time. The law does allow them to have reciprocity if the other state grants it at the same time. The regional exam should be a first step in that direction.

The hearing on House Bill 233 was closed at 1:20 p.m.

CONSIDERATION OF HOUSE BILL 234: House Bill 234 is an act to change the Board of Dentistry to include a dental hygienist; requiring members of the board to be engaged in practice while on the board; requiring the governor to fill vacancies on the board within 30 days.

Representative Bennett, sponsor of House Bill 234, said that this bill provides for one dental hygienist on the board of dentists and it changes the name of the board to the board of dentistry. He thinks it is excellent that the hygienists have done it this way rather than creating their own board. They do work with the dentists. The amendment doesn't remove any of the dentists. It adds another member who is a dental hygienist. The dentists and the hygienists are both happy with this bill. There are about 250 licensed hygienists in the state and about 150 practicing.

Carol McGuire, R. D. H., spoke in support of House Bill 234. See Attachment "D." She presented written testimony for Jeannette S. Buchanan. See Attachment "E."

John Lohman, Montana Dental Association, spoke in support of House Bill 234 as amended. The change of the name is appropriate. The ratio on the board fairly reflects the number practicing in the state today. See Attachment "C."

Rep. Bennett closed testimony by saying that both House Bill 233 and 234 have been given a fair hearing and are worthy of the Committee's do pass consideration.

Chairman Olson asked the Committee members if they have any questions. Senator Lensink stated that he looked at the law last night and thinks these bills are very fair.

CONSIDERATION OF HOUSE BILL 585: House Bill 585 is an act to revise the disciplinary powers of the Board of Dentists; amending limitations on dental advertising and oral hygiene; requiring identification of dentures.

Representative Gould, sponsor of House Bill 585, said this bill is a companion to House Bills 233 and 234. He feels the dentists work hard to watch their own house, and this bill is a clean up in large. It is very important because the Federal Trade Commission says we have to allow advertising. This bill will remove the statutory prohibitions against advertising by dentists. Section 4 will allow the hygienist more freedom to provide services in nursing homes, etc. without the presence of a dentist. Section 5 requires identification of dentures. He checked with the 3 dental labs in Missoula on this. Two said there would be no charge to do this, and one said there would be about a \$3 charge. He has also checked this out in Butte. The Dental Laboratories Association will be putting on a review in Great Falls this summer as to how this can be accomplished in a very inexpensive way.

Fred Stout, Montana Dental Association, said that in addition to the supportive statement he gave initially (see Attachment "A"), he would like to say that they do support this bill because it allows advertising. This is simply to put Montana in line with FTC and still have some control so that the public is not misled. It would make punishment more commensurate with the problem that arises. The statement of intent is an adequate guideline. He said that Section 4 allows more latitude in providing dental hygienists' service, but still maintains good supervision; and the identification of dentures is a problem in nursing homes.

Judy Harbrecht, Montana Dental Hygienists' Association, said the association supports House Bills 233, 234, and 585. They feel these are a positive step in uniting the field. See Attachment "F."

Chairman Olson asked the Committee members if they have any questions. Senator Lensink asked how the name is going to be put on dentures. Dr. Lohman said this was brought to them as a problem last year. One way is to type the name on a little piece of onionskin, and it is processed right into the denture. Senator Norman said this bill clearly relates to the supervisory power, and then all of a sudden the identification of dentures appears in Section 5. He wonders if this bill will not run afoul of the constitutional problem of having each bill address only

one subject. Roger Tippy, lobbyist for the dental association, said he looked up this point when he was drafting the bill. Because of past court cases in Michigna, he feels that as long as there is a reasonable relationship in the various parts of the bill the court will uphold the bill. Senator Norman said he thinks it would be advisable to have a severability clause in the bill so that the trivial thing about the identification of dentures may not put the whole bill in jeopardy. Chairman Olson said that in working session the Committee will put in an amendment.

The hearing on House Bill 585 was closed at 1:40 p.m.

ACTION ON HOUSE BILL 585: Chairman Olson moved that the Committee put in a severability clause. The motion carried unanimously. Senator Ryan moved that House Bill 585, as amended, BE CONCURRED IN. The motion carried unanimously. Senator Lensink will carry House Bill 585 on the Senate floor.

ACTION ON HOUSE BILL 234: Senator Norman moved that House Bill 234 BE CONCURRED IN. The motion passed unanimously. Senator Palmer will carry House Bill 234 on the Senate floor.

ACTION ON HOUSE BILL 233: Senator Lensink moved that House Bill 233 BE CONCURRED IN. The motion carried unanimously. Senator Ryan will carry House Bill 233 on the Senate floor.

ACTION ON HOUSE BILL 235: Senator Palmer moved that House Bill 235 BE CONCURRED IN. Senator Norman said that the problem with this bill is that it gets amended and amended so that in the end it says that please don't smoke in public places. He thinks this would pose a real problem in the hospitals. Senator Lensink said he doesn't think it is possible to pass a law such as this without having the difficulties such as Senator Norman has suggested. He just thinks that it will raise the conscience level of the public and tell them that the Legislature is aware of the smoking problem. Senator Palmer said he agrees with Senator Lensink that this is the thing that can be accomplished by this bill. Senator Norman said he doesn't think that the health officers should charge one dime to enforce this. Senator Palmer moved that the Committee adopt amendments 1 through 4 on Attachment "G." Senator Ryan said he could have supported this law

two years ago when it had meat in it. Senator Lensink said we can get this on the books first and then put some teeth into it. The amendments were adopted unanimously. Senator Palmer moved that House Bill 235, as amended, BE CONCURRED IN. A roll call vote was taken. The motion passed by a vote of four to two. If Representative Ellerd does not have someone in the Senate to carry the bill, Senator Lensink will carry it on the Senate floor.

ADJOURNMENT: There being no further business discussed, the meeting was adjourned at 2:20 p.m.

March 7, 1979) BY THE MONTANA DENTAL ASSOCIATION

I am Fred Stout a Missoula dentist and President of the Montana Dental Association. The MDA concurs with the intent of these bills and supports passage of them. The Dental Association has recognized the need for modernizing the Dental Practice Act. Prior to this legislative session, we requested a study committee represented by a cross-section of distinguished persons from all segments of the field of dentistry. The recommendations of the study group is generally in harmony with these bills.

The motivations for the changes to the Dental Practice Act are wide in scope ranging from simple housekeeping to more significant changes such as alteration of the disciplinary powers of the board to more effectively protect the public. The changes would give the board more latitude in disciplinary proceedings with the options of censure and probation which in most cases are more appropriate than revocation of license. If enacted, it would also bring the act into compliance with F.T.C. initiated court rulings to allow advertising, but at the same time it would prevent misleading or false advertising that would coerce or confuse the public. The dental association is interested in extending preventive dental care and preventive treatment to the public through hygienists treating patients under board approved projects especially in institutions where patients need additional help.

We wish to publicly thank Representatives Gould and Bennett for sponsoring these bills and for the legislature in general for allowing time within their nearly impossible workload to help modernize the Dental Practice Act. If you have questions, I would be happy to try to answer them. Thank you.


The dental hygiene baccalaureate curriculum taught at Carroll is fully accredited by the American Dental Association Commission on Accreditation for Dental Auxiliaries. It is the first and presently the only school in the State of Montana where a student can be educated in preparation to take the National and State Board of Dentist's Licensing Examination to allow practice as a dental hygienist.

As Head of the Dental Hygiene Department, I represent the following people:

- Carroll College, as delegated by Dr. Francis Kerins, President of Carroll College.
- The faculty of the Dental Hygiene Department composed of five registered dental hygienists and nine licensed dentists.
- 33 students presently studying in the department.
- 51 graduate dental hygienists from Carroll College .
- 252 licensed dental hygienists in the State of Montana who look to the Dental Hygiene Department at Carroll as the leader in post graduate and continuing education to maintain their high level of professional competency.
- The thousands of patients who have been served by the students and faculty and who will be served in the future for treatment and maintenance of their oral health.

We support House Bill No. 233 because of Paragraph (3) Section I 37-4-103. The current practice act has limited the education process as we have been unable to educate the students in dental skills necessary for full service as dental hygienists.

Paragraph (3) has been written by the Board of Dental Examiners to provide that academic freedom which will allow the teaching of a broader curriculum for preparation of the dental hygienist and better service to the people of Montana.

The Montana Dental Association supports HB 233 and the concept of regional testing. If approved by the state board, Montana could join with Oregon, Utah, and Arizona in accepting the results of examinations given in Portland to applicants for a dentist's license. A shortage of adequate examination facilities here in Helena has sometimes caused difficulties for candidates before the board.

The statement of intent adopted by the House committee is satisfactory to the MDA as far as fee increases for dentists are concerned.

The Montana Dental Association supports HB 234 as amended. The change of name to Board of Dentistry is appropriate, and the dentist-hygienist ratio fairly reflects the numbers of dentists and dental hygienists actively practicing in Montana today (about 420 dentists and 75-90 hygienists).

House Bill 585)
March 7, 1979) STATEMENT IN SUPPORT
 MONTANA DENTAL ASSOCIATION

The Montana Dental Association supports HB 585. The primary purpose of this bill is to remove statutory prohibitions against advertising by dentists and to allow advertising subject to regulation by the Board of Dentistry. The bill shifts the definition of other forms of unprofessional conduct from the statute to administrative rules of the Board. The House committee's statement of intent is an adequate guideline for the Board to follow.

Section 4 is a redefinition of the supervision required in the dentist-dental hygienist relationship which will allow the hygienist more latitude in providing oral hygiene services in nursing home settings and the like, without compromising essential safeguards. Section 5 is a simple identification requirement for dentures which would have useful applications in forensic dentistry (identification of burn victims, etc.) and in sorting out dentures cleaned in a group in ultrasonic cleaning devices. The cost would be no more than two or three dollars per set of dentures.

My name is Carol McGuire. I am a practicing dental hygienist in the State of Montana and Past President of the Montana Dental Hygienists' Association. I am speaking in support of House Bill 234 introduced by Representative W.F. Bennett.


The purpose of the proposed changes is to gain representation within our regulatory agency, the Board of Dentists. Dental hygienists are currently examined, licensed, and regulated by the Board, and therefore should be represented as a member of this regulatory body.

Dental hygienists must be graduates of an accredited school and must be licensed to practice in every jurisdiction of the United States. This license is granted only after satisfactorily exhibiting competence by examination, as are dentists.

The Board of Dentists is currently composed of five (5) dentists and within the past three years they have examined and licensed 133 dentists and 121 dental hygienists. The addition of the dental hygiene member will add continuity to the Board and enhance the Board as a consumer protection agency as the public would benefit from representation of a profession whose major concerns encompass all aspects of preventive dentistry.

STATEMENT OF SUPPORT BY AN AUTHOR

Mr. Chairman and Committee Members;

I am Jeannette S. Buchanan, R.D.H., a licensed and practicing Dental Hygienist in the State of Montana. I am the chartering member and a Past President of the Montana Dental Hygienists' Association and the Immediate Past President of the American Dental Hygienists' Association. I am writing in support of House Bill 234 which was introduced by Representative W.F. Bennett.

The purpose of this proposal is to gain representation in our regulatory agency, currently called the Board of Dentists. The Dental Hygienists, who is licensed to practice, is subject to the laws governing practice, as well as the rules and regulations imposed by the Board and therefore should be represented as a member of its regulatory body.

The Dental Hygienist must be a graduate of an accredited school and must be licensed to practice in every jurisdiction of the United States. The license to practice is issued after satisfactorily exhibiting competence by examination, as are dentists.

The Board of Dentists, currently composed of five dentists, conducts this examination and grants the license to practice to assure the public of adequate care. The activity of the Board during the past three years has been to examine 121 hygienists and 133 dentists. The Board sets and approves requirements and standards of education and practice.

A conciliatory agreement was reached in a meeting with other members of the dental profession. An amendment was offered by the Montana Dental Hygienists' Association. The original proposal sought to place two hygienists on the Board for continuity and to keep the membership at an odd number in order that every member could vote.

HB #233

Section 1. Section 37-4-103. in amended form, page 2, line 15

This amendment would allow a dental program to offer their students the benefit of an innovative and full preparation curriculum. An institution of higher education is going to have the best interest of the constituents at heart and must also meet a full responsibility to their students to give them a complete education.

HB #234

Dental Hygienists in Montana constitute an integral component in the State's health care delivery system. The dental hygiene profession, however, does not have a single member on the Montana Board of Dentists, which regulates dental hygienists in the State. HB 234 would alter the composition of the five (5) member, all dentist Board, to include a registered dental hygienist member.

In the past three (3) years, the number of dental hygienists in Montana has increased 107%. At present, there are 242 registered, licensed dental hygienists and 753 registered, licensed dentists; a ratio of 3 to 1. The implication for the future is obvious.

During the year 1978, revenue from licensure application, examination and renewal fees for the dental hygienists totaled well over two thousand dollars (\$2,000.00).

Eighteen (18) states presently have voting dental hygienists on their Boards and twenty (20) additional states are in the process of placing a hygienist member on their Boards.

It is an unusual situation for a licensed profession not to be represented on the agency which regulates it. The hygienists of Montana are ready to assume their share of dentistry's responsibility and involvement in protecting the health of the public. Dental hygienists are educated, skilled and highly competent members of the dental health profession. Their request to have a dental hygienist serve as a voting member on the Board of Dentists seems a logical and sound approach to achieving quality dental health care for the people of Montana.

HB #585

STATEMENT OF INTENT.

Sections 1 and 3 set up a range of sanctions which the Board may impose on any dentist or

dental hygienist whose conduct constitutes grounds for sanctions. This is intended to expand the Board's powers on the less stringent end of the scale, by adding censure and probation to the suspension and revocation powers the Board now has. Often a problem can be corrected with much milder sanctions when efforts to suspend or revoke might be counterproductive.

Section 4, line 16- page 8 through line 8-page 9

The fact that the hygienist is examined and licensed assures the public of competencies to practice those functions for which the hygienist is licensed. The hygienist functions as prescribed by the treatment plan which has been developed by a licensed dentist. With the inclusion of the definitions of " supervision " as proposed, the hygienist would have greater latitude within the community health picture.
