

MINUTES OF THE MEETING  
BUSINESS & INDUSTRY COMMITTEE  
MONTANA STATE SENATE

March 16, 1979

The meeting of the Business and Industry Committee was called to order by Chairman Frank Hazelbaker on the above date in Room 404 of the State Capitol Building at 10:00 a.m.

ROLL CALL: All members were present, with the exception of Senator Peterson who was excused.

DISPOSITION OF HOUSE BILL 731: The hearing on House Bill 731 was held on March 15, 1979.

Attorney Bob Pyfer told the Committee that HB 731 would require a Statement of Intent because it creates new rulemaking authority.

Senator Goodover moved that HB 731 Do Not Pass. Senator Lowe seconded the motion.

A Roll Call Vote was taken on the motion that HB 731 Do Not Pass. The Committee voted 5-4 that HOUSE BILL 731 BE NOT CONCURRED IN. This Roll Call Vote is attached to the minutes.

Chairman Hazelbaker will explain the adverse Committee Report on the floor.

DISPOSITION OF HOUSE BILL 454: The hearing on House Bill 454 was held on March 15, 1979.

Senator Lowe moved that House Bill 454 Do Pass.

Senator Dover offered an amendment to HB 454 as follows:

1. Page 1, line 23.  
Following: "method"  
Strike: "APPROVED BY THE BOARD"

The amendments were adopted by the Committee. Senator Hager was the only "no" vote.

The Committee voted unanimously that HOUSE BILL 454 BE CONCURRED IN AS SO AMENDED.

Senator Lowe will carry House Bill 454 on the floor.

DISPOSITION OF HOUSE BILL 414: Attorney Bob Pyfer stated there was a technical problem with HB 414, and he proposed the following amendment.

1. Page 3, lines 12 and 13.  
Following: "violates" on line 12  
Strike: "this section"  
Insert: "[this act]"

Senator Dover moved that the proposed amendment be adopted. The Committee voted unanimously to adopt the proposed amendment to House Bill 414.


Senator Kolstad moved that the Committee table House Bill 414. On a Roll Call Vote the motion was killed by a tie vote of 5-5.

Senator Lowe moved that House Bill 414 Do Not Pass. A Roll Call Vote was taken on the motion. The Committee voted 7-3 that HOUSE BILL 414 BE NOT CONCURRED IN AS SO AMENDED.

Chairman Hazelbaker told the Committee that HB 887 will be heard in the Committee on Monday, March 19.
