

MINUTES OF THE MEETING

March 23, 1979


The meeting of the Senate Rules Committee was called to order by Chairman Stephens at 9:15 a.m. on the above date in Room 331 of the State Capitol.

RECONSIDERATION OF S.B. 70: John Larson reported that he has spoken to Joe Roberts of the Governor's staff and he has agreed that the statement of intent will be attached to this bill as an amendatory veto. On motion of Senator Hazelbaker, the bill was reported out of Committee and sent to enrolling.

CONSIDERATION OF HJR 57: (introduced by Robbins, Mehrens) This is a joint resolution commending the National Guard for services rendered the institutions during the strike, and needs a ruling for suspension of the rules to allow its introduction in the Senate. Senator Jergeson so moved. Motion carried.

CONSIDERATION OF HJR 52: (introduced by Scully) Representative Scully appeared before the committee and gave the history of why this resolution missed the transmittal deadline. It would appear there was a mixup in the House which caused the delay. Senator Stephens reminded the members that we had already denied two other requests for suspension of the rules which is the question here, and that there will likely be other requests. Senator Kolstad moved that we suspend the rules because we need a resolution like this even though his SJR 6 was killed. On a tie vote of three to three and four members absent, the question is dead.

The meeting adjourned at 9:35 a.m.

STATEMENT OF INTENT

SB 70

The legislature intends that persons engaged in the transportation of buildings other than mobile homes be permitted to offer such transportation service on a statewide basis rather than on a regional basis. Rules adopted under this bill shall provide for the reissuance of certificates of public convenience and necessity to those persons engaged solely in the transportation of buildings and for the modification of certificates issued to persons authorized to engage in other activities in addition to building transportation.
