

MINUTES OF THE MEETING
FINANCE AND CLAIMS COMMITTEE
MONTANA STATE SENATE

April 9, 1979

The thirty-fifth meeting of the Finance and Claims Committee met on the above date in room 108 of the State Capitol Building. Following roll call the meeting was called to order by Senator Himsel, Chairman, at 8:08 a.m.

ROLL CALL: All members present.

CONSIDERATION OF HOUSE BILL 921: Senator Regan said this one on the airplane still had some questions and thought it should be held on to longer until they can resolve the problems if at all possible. There is some question on the money.

Senator Story: The money is to pick up the hangers. Joe Roberts is picking up the amendment. That is why this was changed, because they had to pay for the hangers.

Senator Himsel: We will let this go until we get the amendment.

DISPOSITION OF HOUSE BILL 125: This was the bill on revenue sharing.

Motion by Senator Story that we do not concur. Voted and passed.

DISPOSITION OF HOUSE BILL 919: Motion by Senator Regan to be concurred in.

Senator Smith: I question this. There are a lot of contributions sent in to the Cancer Society. Doesn't any money come in for this sort of thing?

Senator Himsel: I would think it would be a natural part of the Health Department. Why should this not be the same? Why do they need an additional \$60,000?

Senator Story: They came in and asked for this and we wanted to know who the people were and what they did. The cost at this time to the Health Department is \$18,000.

Substitute motion by Senator Aklestad that House Bill 919 be not concurred in. He said he did not think it was just the money but the people that are moving around the community etc. I don't think they will try to keep track of this anyway. I think it is a falacy.

Senator Regan: The testimony seemed to indicate some areas in Montana had high cancer rates. It would permit a follow up to see what has happened to the individuals. I think there is some merit in the bill.

Senator Boylan: I think there is enough money in the Board of Health and we can give them the enabling legislation without the money.

Senator Thiessen: They have to report to the hospital anyway. They can extend one more column and put it on the same sheet.

Senator Himsel: A lot of this is in Doctor's offices, clinics, etc.

Senator Boylan: Can't we amend this to put in without the money?

Senator Himsel: I think not. It is an appropriation bill.

The substitute motion to not concur was voted and passed.

CONSIDERATION OF HOUSE BILL 472: Motion by Senator Etchart to be concurred in.

Senator Himsel: They go to conferences and work somewhat like the legislature. Someone introduces the problem and they work on it morning noon and night. They wind up with the consensus that they go ahead with a uniform law proposal.

Senator Story: What are they using the money for?

Senator Himsel: \$3100 is dues per year plus the travel expenses.

Senator Boylan: Who do they report back to?

Senator Story: They get a report back on the laws.

Senator Nelson: We did not appropriate for this 2 years ago. Mr. Blewett was the only one who attended and he did so at his own expense.

Senator Story: The laws are not uniform. I don't think much of them.

Senator Etchart: In defense of the bill, I think it is good strategy to have someone there from Montana.

Senator Himsel: I understand there is \$1,000 for travel in addition to this. That probably picks up some of the difference. \$7200 was dues. The per diem was cut out.

This bill was held for further information.

DISPOSITION OF HOUSE BILL 584: Senator Etchart: This was in the institutions subcommittee. Mental Health started out with High federal match and now we have to pull it in. We had to increase over \$3 million this year, and they are still kicking and screaming.

Senator Story: The feds warned us. They said it was 90% and each year it would go down 10%.

Senator Fasbender: They are locally controlled. If the regions want to maintain it at whatever level they want, they were to do so, but it was locally controlled, and that is the reason we are paying for it.

Motion by Senator Fasbender that we do not concur in House Bill 584.

Senator Thiessen: They can only sponsor 50% of what they raise?

Senator Fasbender: The state cannot exceed over 50%.

Senator Himsel: This bill would eliminate the requirement that state funds may not exceed 50%. We could end up paying a lot for it.

Senator Smith: If it is not taken care of locally, we may have that many more back in Warm Springs and that is more money.

Senator Aklestad: They will still be able to have the treatment but the state will not back up more than 50% of the costs.

Senator Himsel: If we kill this bill, the state's contribution cannot exceed 50%.

Motion was voted and passed.

DISPOSITION OF HOUSE BILL 868: Motion by Senator Regan to be concurred in. Voted and failed.

Vote reversed, Be not concurred in; roll call vote, attached.

DISPOSITION OF HOUSE BILL 472: Diana Dowling is here and we can get this bill straightened out. What is the dues amount?

Diana Dowling: The dues are \$3100 a year; they are set according to the population. The meeting is in the code commissioners' office and the members are appointed by the governor. The original bill provided travel expenses; it was amended in the House to just cover the dues.

Senator Himsel: Is there travel in the legislative council budget? Dowling: There is for me. The other members are Dean Sullivan, J. T. Harrison, and Alex Blewett. Air fare is \$320, it costs \$37 per night for a motel and about \$13 a day for meals. The council paid her way to the meeting the last time.

Senator Himsel: How often do they meet? Dowling: Once a year for a week.

Senator Smith: The question that I would have is \$3100 for the dues--\$6200 for the biennium--What happens if we don't have some one who goes who gets some good use out of it? If the other part isn't funded, maybe some people can't go.

Dowling: Alex Blewett and Harrison have been paying their own way.

Senator Himsl: Isn't there any organizational support to help pay for this? Dowling: They do not. We just ask for travel for the annual meeting. Alex gets the other trips paid for.

Motion by Senator Etchart that House Bill 472 be concurred in. Voted and passed, Senator Goodover to carry the bill.

DISPOSITION OF HOUSE BILL 357: This bill was heard in the employee Compensation committee and the Departments would reward the employee on the basis of a merit or incentive plan. If they could show they saved the state some money, they could participate in the amount of savings. If you will look at page 8, section 7-- it is difficult to administer--so many laws are involved in it.

Motion by Senator Boylan be not concurred in. The select committee would be willing to take the money out. Discussion was held on the cost of the incentive and the merit of it.

Senator Regan: I would like to amend section 9 out. Then we can try it for 2 years, look at the amount and see what has happened. I think it might be a good incentive program.

Motion by Senator Regan to strike section 9 in its entirety and to renumber the subsequent sections.

Senator Etchart: Was there any discussion as to how it fits into the pay plan?

Senator Himsl: Just a bonus.

Senator Smith: On page 8, section 7--I am certainly for economy in the government. The question is --are we then obligated to pay up to 25% of the cost?

Senator Himsl: The \$10,000 was really administrative costs. I don't know about the delivery of services.

Senator Regan: There are a number of large corporations who have used this with their employees to save money in their operations. I would say you would cover this exactly like a corporation.

The motion was voted on. The amendment was voted yes, the motion then was to be not concurred in as amended. Voted and passed.

DISPOSITION OF HOUSE BILL 356: Motion by Senator Fasbender to be concurred in.

Senator Story: The fines presently go into the general fund.

Senator Fasbender: This reduces their earmarked revenue that comes in.

Senator Story: But they are used in their revenue predictions.

Senator Fasbender: We are taking the money from the fines and funding their retirement. It would be direct funding.

Senator Story: A lot of the public are misunderstanding it. Every time anyone gets caught they will say it is to pump up their retirement.

Senator Smith: If the person is in violation they should be able to fine him anyway. We have to build up that retirement so that it is funded.

The motion was voted and passed, Senator Smith to carry it.

DISPOSITION OF HOUSE BILL 284: Motion by Senator Regan that the bill be concurred in. She said she had Curt check and the money will go where it is supposed to.

Senator Story: The fiscal note says \$153,000 the first year and \$362,000 the second year, to increase the foster care.

Senator Smith: Are you sure they will get the money? Senator Regan: In our subcommittee I wanted to know. I will ask Curt to address your question.

Curt Nichols, fiscal analyst: The figures are correct that are in the bill.

Senator Story: On the sheet of paper that the short lady gave us ----- Senator Regan: That was on day care, this is on foster care.

Senator Regan: When the subcommittee worked this budget we gave very nominal increases to both day care and foster care knowing these bills were coming out. We thought we would let the House set the payment particularly in view of the fact that they had had no payment increase before. The increase in the subcommittee was 7 3/4 and 7 1/4. The inflationary figure is far greater than that.

Senator Smith: I did not sit on this subcommittee. I am wondering-- isn't the institution funded in a different manner than these. I am wondering about the word on page 1, line 20--if we pass it with institutions, does it get institutions to come in for additional money over and above the SRS budget?

Senator Regan: I had the same concern. The problem is that the 3 biggest ones take children on contract--and that was pretty bad. The Florence Crittenton Home did not get the increase and it is an institution. We would seriously hurt them. I talked to Keith Colbo about that.

Senator Fasbender: The language specifically precludes that. On the bottom of page 1 and on page 2.

Senator Story: We had better keep it. They are picking up a lot of costs on their own. I think we had better keep it as it is. There is a severe shortage of good foster homes.

Senator Himsel: There is reference to other funds. Are they federal funds?

Senator Regan: Yes, and there is some county funds get kicked in if they qualify. It is a $\frac{1}{2}$ match with the county.

Senator Smith: What about line 16 and 17 on page 1?

Senator Regan: The increase for the county is very slight. It is the aid to dependent children, I think.

Senator Himsel: In the bracket down on the other funds--what is the source? Curt Nichols: County funds. The counties pay $\frac{1}{2}$ of the non federal care. Foster care is 70% and no federal funds. They pay about 50% of the non-federal share. Then the counties pay $\frac{1}{2}$ and the state pays $\frac{1}{2}$.

The motion was voted be concurred in, passed, Senator Regan to carry the bill. Senator Aklestad voted no.

CONSIDERATION OF HOUSE BILL 921: This is the bill on license plates.

Senator Fasbender: Under the law if anyone changes cars they can get an additional license plate.

John Fitzpatrick, OBPP: Money was appropriated for the manufacture of license plates. The law says that if there is a title change the county treasurer can require that you get a new set of plates. It is to the counties advantage to get it. There were 25,000 more sets of plates than we budgeted for. Motor vehicle earmarked revenue goes into this.

Some discussion was held on the possibility of amending the bill, and it was left until a later time.

DISPOSITION OF HOUSE BILL 923: This would standardize the accounting system of the vo tech centers. They want to standardize and go on SBAS. They would have to pay for it on a monthly basis. \$50,000 went into the administration budget into the bill. They couldn't agree on what was to be done. They finally said they would go on SBAS and get it started with. The language has to be passed so that we can handle it as the funds go into the county funds as opposed to the state funds. Senator Fasbender also said there is no appropriation in it.

Senator Himsel: Post secondary vo tech money goes into the state instead of the counties. This would be centralized accounting of the vo tech center. It was done at their request.

Senator Nelson: The subcommittee thinks it is a must.

Senator Boylan: What about the delay in paying bills when it goes into SBAS?

Motion by Senator Aklestad be concurred in. Voted and passed. Senator Fasbender to carry the bill on the Senate floor.

DISPOSITION OF HOUSE BILL 773: Senator Himsl said that his feeling on this would be to let it go for 2 years and come in with a bill to broaden the motor boat tax money to do this waste problem.

Senator Smith: The question is how much money is really in that trust fund and how long is it going to last?

Senator Himsl: Apparently there is plenty of money in the trust fund according to the figures that were given to me.

Senator Smith: There should be some way we could address this problem.

Senator Thiessen: I just came from a meeting tonight for a study for continued service in another area. I don't think we should go out and give this type of subsidization.

Senator Himsl: We gave \$69,000 to the Giant Springs project, \$500,000 to 908--MHD project, Air ports etc. We have to look at the revenue projections, too.

Motion by Senator Fasbender that H.B. 773 be not concurred in. Voted, passed, Senator Story to carry the bill.

CONSIDERATION OF HOUSE BILL 692: The thrust of this is that they cannot come back on the counties to get more money from the state.

Motion by Senator Nelson be not concurred in.
Substitute motion by Senator Fasbender, be concurred in.

Senator Thiessen: What was the amendment?

Senator Nelson: It was not put in. The only one is the one from the old bill. He said in Toole county the action from Browning of taking people to Great Falls, etc. was making a much higher hospital bill, and this bill would hurt the local hospital in his county.

Senator Aklestad: The hospitals will have to raise the rates. The little hospitals might go under in the process.

Senator Regan: This fight goes back a long ways. That is really not what happens in this bill. It says if you are eligible and take medicaid you don't put any additional cost back on the county. Medicaid should be the total cost and not a big over-run. The question of what medicaid will or will not pay will

be settled in court. Either they will be forced to pick up the cost of bad debts and construction and improvements or they will not.

Senator Himsl: In Public Health a few years ago there was a certain agreement in the health delivery services that were being met. The pharmacists might agree to 85% of the standard rate. The hospitals were being paid about 90% of the rate. They were not concerned because a 90% return is a good return. We are asking them to discount about 10% on the bill. Many scale it down more than the hospitals. Their figures include money the federal government was not paying. I think it is true there is a question of what is actual cost and what their agreement is with them.

Senator Regan: I think what happened was about 6 years ago SRS made a contract and they paid 100%. It was illegal. The hospitals screamed when we cut this back.

Senator Aklestad: A lot of the costs brought onto the hospitals is due to the regulations the feds ask for. This is increasing their costs. We are only reducing the cost and not the regulations.

John Fitzpatrick: The rule is that an audit is conducted and then a determination is made on the cost. He explained what happens on this. If the expenses exceed what SRS is thought to be reasonable services in a certain area. Without this bill, if SRS should reduce this amount, the counties use up the maximum levy for the poor fund, the state will have to go back and pick up what the SRS department did not pay. This just says they will have to figure out another way around it.

Senator Nelson: If this bill passes, I would like to amend it.

The meeting was adjourned, since committee members had to be at other meetings, and the committee will be subject to the call of the chair.


