

MINUTES OF THE MEETING  
LEGISLATIVE ADMINISTRATION COMMITTEE  
MONTANA STATE SENATE

December 1, 1978

The meeting of the Legislative Administration Committee was called to order by Chairman Kolstad on the above date in Room 137 of the State Capitol Building at 10:00 a.m..


