January 6, 1981

Chairman Fagg convened the Rules Committee at 11:20 a.m. in Room 104. All members were present with Rep. Sivertsen, Rep. Lund, Rep. Dussault and Rep. Kemmis arriving late.

Chairman Fagg turned the chair over to vice chairman Marks in order to present discussion on House Resolution No. 1 for amendments.

Discussion was held on amending Page 2, section H-6. A motion was made by Rep. Fagg to Amend, Page 2, line 13, following "spouses", by inserting "and their children 12 years of age and older". The motion was seconded by Rep. Moore. The motion carried with Rep. Dussalt, Rep. Menahan and Rep. Kemmis voting no.

Rep. Moore made a motion that Page 3, line 10 be amended to read: "Public Health" rather than Human Services. Rep. Fagg voiced his opposition to this change as well as Rep. Dussault. The motion failed 7 to 3 on a roll call vote, (see Attachment 1).

There was discussion on adding a new section on Page 3, after line 23, "H3-3. The speaker, majority leader and minority leader shall be ex officio members on all committees." Renumber: all subsequent sections. The motion was made by Rep. Fagg and seconded by Rep. Kemmis. The motion carried unanimously.

Rep. Fagg made the motion to adopt the resolution as amended. The motion was seconded by Rep. Moore and was carried without opposition with Rep. Kemmis voting to pass. There was some discussion on House Bill 1.

The chair was turned by to Rep. Fagg from Rep. Marks and Chairman Fagg adjourned the meeting at 12:25 p.m.
