MINUTES OF THE MEETING OF THE HOUSE EDUCATION COMMITTEE January 7, 1981

The Education Committee met at 12:30 p.m. on January 7, 1981, in Room 129 of the Capitol Building, with Chairman Ralph Eudaily presiding and all members present, except Reps. Dussault and Yardley who were excused.

Chairman Eudaily welcomed the members of the committee and introduced the support staff - the secretary, Emelia Satre, and the researcher, Lee Heiman. He then had each committee member introduce himself.

Chairman Eudaily explained the Rules of Procedure (copies of which had been given to each member and a copy of which is Exhibit 1 of the minutes). He said a copy of this would be posted in or near the committee room so that individuals wishing to testify would be aware of the procedure.

Chairman Eudaily asked the members how they felt about the no smoking rule. The consensus of the committee was to go with the rule and to take brief breaks during the meeting if needed.

Rep. Donaldson announced he was chairing a subcommittee on education financing and if any member was interested he would be welcome to come to the meetings.

Chairman Eudaily asked if any member knew if the official title of the committee was different than that being used and, if so, when it had been changed. He said he had been approached on this by J.D. Holmes who felt the title included the word "Cultural." Without that word Mr. Holmes felt there would be no place to send those kind of bills. Rep. Vincent said the committee's name had not been legally changed in the Rule Book so the proper name is "Education Committee," and it would take a majority vote of the House to change the name.

Rep. Meyer moved the meeting be adjourned. Meeting adjourned at 1 o'clock.

RULES OF PROCEDURE

EDUCATION COMMITTEE

47th Legislative Session

Room 129

- Individuals wishing to testify must sign the witness sheet prior to the committee hearing. Your testimony will not be recorded if you do not sign the witness sheet. The witness sheet is located near the door as you enter the room.
- 2. The sponsor of the bill will open and close the presentation.
- 3. Proponents will speak first, followed by opponents. The time allowed is subject to limitation by the chair.
- 4. Proponents and opponents should not be repetitious in their testimony presentations.
- 5. Questions by committee members shall be directed to proponents and opponents at the close of the presentation unless otherwise authorized by the chair.
- 6. All questions will come from the committee. No questions shall be directed between proponents or opponents.
- 7. All discussion will begin upon direction from the chair.
- 8. Amendments to bills under consideration by the committee must be presented in written form.
- 9. Anyone wishing to smoke may do so outside Room 135 (outer hall).
