

EXECUTIVE SESSION OF THE JUDICIARY COMMITTEE
January 12, 1981

The Executive Session of the Judiciary Committee was called to order by Chairman Kerry Keyser, presiding, at 10:35 am on January 12, 1981. All members were present except Rep. Shelden who was excused.

HOUSE BILL 44 REP. SEIFERT moved House Bill 44 do not pass. The motion was seconded.

REP. DAILY offered a substitute motion that the two amendments as proposed by REP. BRAND be adopted, and so moved it. DAILY noted people who testified would support the bill if the amendments were added.

The amendments were read to the committee. The first amendment would be added after the word "ended." on page 1, line 25. The second amendment would be inserted after the word "death" on page 1, line 11. The amendments were unanimously voted in favor of.

REP. KEEDY moved line 14 and 15 the words "within two days" be stricken and the title be amended. Motion passed unanimously.

REP. EUDAILY moved line 14 page 1 strike "every" and put in "a reasonable" attempt. Motion passed unanimously.

REP. KEEDY moved line 11 and 12 on page 1 strike "Any hospital or health care facility where a death occurs or any". Motion passed unanimously.

REP. HUENNEKENS moved a copy of the bill with it's changes as passed above be drafted up for the committee to see. After a brief discussion HUENNEKENS withdrew his motion.

REP. DAILY moved do pass as amended.

A rollcall vote resulted. The bill was defeated as amended by a vote of 10 to 8, with one absent. Those voting no were: Keyser, Seifert, Conn, Curtiss, Eudaily, Hannah, Iverson, Matsko, Yardley, and McLane. Those voting yes were: Bennett, Daily, Abrams, Anderson, Huennekens, Keedy, Teague and Brown.

REP. YARDLEY noted there should be an affirmative action expressed. The committee was reminded of the motion by REP. SEIFERT of do not pass and the above vote was reversed. Those voting yes for do not pass were: Keyser, Seifert, Conn, Curtiss, Eudaily, Hannah, Iverson, Matsko, Yardley and McLane. Those voting no were Bennett, Daily, Abrams, Anderson, Huennekens, Keedy, Teague and Brown.

HOUSE BILL 68 REP. HUENNEKENS moved the bill do not pass. It was seconded by Alison Conn.

CHAIRMAN KEYSER read a few of the sections the bill would affect. He noted if this bill were to be passed all the sections would be stricken.




After a brief discussion the committee voted do not pass with the exception of REP. TEAGUE who voted in favor of the bill.
