

SUB-COMMITTEE FOR ADMINISTRATIVE CODE BILLS  
January 12, 1981

The sub-committee for Administrative Code Bills met at 5:00 p.m. on January 12, 1981, in Room 436, with Chairman Walter R. Sales presiding and committee members Joe F. Kanduch and Glenn H. Mueller both present. Also attending were Ms. Lois Menzies, researcher for the Legislative Council, David Niss of the Legislative Council and Representatives Hal Harper and Chris Stobie, sponsors of the bills to be discussed.

HOUSE BILL 74, sponsored by REP. HAL HARPER, was the first topic of discussion. The bill was introduced to generally revise and clarify the laws relating to the administrative rulemaking and enforcement, which involves the Administrative Code Committee.

Discussion followed and upon motion made by Rep. Sales and seconded by Rep. Kanduch, a DO PASS AS AMENDED vote on two amendments passed unanimously. These amendments are recorded as Exhibit A.

HOUSE BILL 38, introduced by REP. CHRIS STOBIE, a bill relating to omissions from the administrative rules of Montana or the Montana Administrative Register was discussed next.


Rep. Sales noted that from previous testimony of Rep. Stobie there wasn't good enough public notice of a change in the codes, and he felt the proposed amendments in the bill would improve on this.

David Niss explained the process of notification, when a code is changed and who is notified.

Following the discussion motions were duly made and seconded by individual committee members to adopt a DO PASS AS AMENDED all amendments shown in the recorded Exhibit A. The motions were unanimously passed.
