Insert: "All bills and resolutions will be submitted to"

The motion carried unanimously.

Rep. Marks moved to make a motion to amend. There was a roll call vote and the move was carried by a vote of 6 to 3. Rep. Marks made a motion to amend the previous Rules Committee meeting amendment No. 1, which would delete (g) appropriation bills. This motion carried with a vote of 6 to 3.

There was a move by Rep. Marks that until the day the bill, SJR 1, is passed by the House and Senate and adopted, any of the rules contained in this bill are not effective until passage of the bill. Therefore, as far as bill requests, and introduction under the rules, we are now operating under the old rules. This motion was unanimously carried.
