#### HOUSE RULES COMMITTEE 47th Legislature

#### February 11, 1981

Chairman Fagg convened the Rules Committee at 11:00 a.m. in Room 343. All members were present with the exceptions of Rep. Moore, Rep. Spilker, Rep. Dussault arriving late and Rep. Sivertsen and Rep. Menahan being absent.

#### Senate Bill 340

Senator Stan Stephens presented the bill which would amend and clarify the matter of appointments of and filling a vacancy on the districting and apportionment commission to allow the respective party position to be filled by the Majority or Minority leader of the party in which the vacancy occurs. Rep. Spilker arrives. It was moved by Rep. Lund to DO PASS, motion carried unanimously.

#### House Bill 429

Rep. Vincent again presented the bill. There was discussion and it was generally agreed, if amended, it could be brought to the floor of the House.

Rep. Dussault and Rep. Moore arrived at this time.

Motion by Rep. Vincent to amend page 1, line 25 by striking "budget and finance" and inserting "appropriations and revenues" The motion carried.

Motion was made by Rep. Marks to add " in non-budget years, appropriations and revenue items may not be introduced unless it is approved by a two-thirds majority. Motion carried with Rep. Kemmis and Rep. Dussault voting "NO".

Motion by Rep. Kemmis to have appropriation and revenue sessions on even numbered years and general sessions on odd-numbered years. Substitute motion by Rep. Fagg to have a transition session in 1983 consisting of 90 days, a 60 day general session in 1984 and a 45 day appropriations and revenue session in 1985 and then 60 day and 45 day from then on. Rep. Moore called the question. Motion carried with Rep. Marks voting NO.

A motion by Rep. Lund to DO PASS AS AMENDED, question called by Rep. Moore and motion carried with Rep. Marks and Rep. Dussault votion "NO"

There being no further business, the meeting was adjourned by Rep. Fagg.
