Page 1

The meeting was called to order at 2:00 p.m. in Room 104, State Capitol, with all members present, except REP. MOORE, who was absent.

EXECUTIVE SESSION.

HB 709.

The subcommittee chairman, REP. DONALDSON, reported to the Committee, recommendations for HB 709. (EXHIBITS A,B,C,& D)

REP. BENGTSON moved that the Committee accept the subcommittee recommendations for HB 709 and fund HB 460. REP. BENGTSON included as part of her motion, that HB 469 be funded separately and that HB 835 be incorporated into HB 709.

REP. SHONTZ made a substitute motion to approve the subcommittee recommendation with the exception of HB 601. The motion, as made by REP. SHONTZ was UNANIMOUSLY APPROVED by the members of the Committee.

REP. SHONTZ moved that HB 709 do pass as amended. The MOTION WAS APPROVED, with 12 members voting aye and four members voting no.

HB 29.

REP. BARDANOUVE moved that the Committee table HB 29. The MOTION PASSED, with 14 members voting aye and two voting no.

SB 74.

REP. QUILICI moved that the Committee do concur in SB 74. The MOTION WAS UNANIMOUSLY APPROVED by the Committee members.

SB 118.

REP. SHONTZ moved that the Committee table SB 118. The MOTION WAS APPROVED, with nine members voting aye, seven voting no.

HJR 38.

REP. STOBIE moved that the Committee table HJR 38. REP. WALDRON made a substitute motion that HJR 38 do not pass. REP. WALDRON's motion as stated was UNANIMOUSLY APPROVED by the Committee members.

HB 19.

REP. HURWITZ moved that the Committee do not pass HB 19. REP. DONALDSON made a substitute motion that the Committee pass on HB 19 for the day. The MOTION as made by REP. DONALDSON was APPROVED with 14 members voting aye and two voting no.

REP. DONALDSON stated that four persons were added to the program in 1980.

REP. THOFT made a substitute motion that HB 290 do not pass.

REP. QUILICI made a substitute motion to all prior motions to amend HB 290 to increase monthly payments to silicosis victims to \$200 and for spouses to \$100 and that surviving spouse income remain the same.

The substitute motion as made by REP. QUILICI was UNANIMOUSLY APPROVED by members of the Committee.

REP. QUILICI moved that HB 290, do pass as amended. The MOTION was UNANIMOUSLY APPROVED by those in attendance.

SB 300.

REP. LORY moved that SB 300 do not pass. The MOTION was APPROVED with 13 members voting aye and three voting no.

REP. CONROY moved that the Committee reconsider its action on SB 300. The MOTION was UNANIMOUSLY APPROVED.

REP. SHONTZ moved that the Committee approve the amendments to SB 300. The MOTION was UNANIMOUSLY APPROVED.

REP. SHONTZ moved that SB 300 be concurred in as amended. The motion was unanimously approved.

HB 307.

REP. BARDANOUVE moved that HB 307 do pass. The MOTION was UNANIMOUSLY APPROVED by the Committee members.

REP. BARDANOUVE moved that HB 319 do not pass. The MOTION was UNANIMOUSLY APPROVED by the members of the Committee.

SB 319.

SB 319 was unanimously tabled by the members of the Committee.

HB 362.

REP. STOBIE moved that HB 362 be tabled. REP. WALDRON made a substitute motion that HB 362 do not pass. The MOTION was APPROVED by the Committee, with 15 members voting aye and one member voting no.

HB 366.

REP. SHONTZ moved that HB 366 do not pass. The MOTION was UNANIMOUSLY APPROVED.

HB 418.

REP. BARDANOUVE moved that HB 418 be tabled. The MOTION was UNANIMOUSLY APPROVED.

HB 446.

REP. SHONTZ moved that HB 446 do not pass. REP. THOFT made a substitute motion that HB 446 be tabled.

REP. LORY made a substitute motion for all motions pending that HB 446 do pass. The MOTION, as made by REP. LORY, FAILED, with 14 members voting no and two voting aye.

REP. CONROY moved that HB 446 be tabled. The MOTION was UNANIMOUSLY APPROVED by the members of the Committee.

REP. WALDRON moved that HB 623 be amended to read \$155,000. The MOTION was UNANIMOUSLY APPROVED by the Committee members.

REP. THOFT moved that HB 623 do not pass. REP. SHONTZ asked how much this bill would reduce the spending in other areas. REP. HEMSTAD stated that she supported HB 623.

REP. LORY made a substitute motion for all motions pending that HB 623 do pass as amended. The MOTION FAILED, with seven members voting aye and nine voting no.

MR. RAY BLEHM, Firemens' Representative, City of Billings and Billings Fireman, stated that Amendment A was requested by PERS for administrative purposes. Mr. Blehm stated that Amendment B is to leave funds in PERS for temporary layoffs, etc. He stated that Amendment C leaves an escalator clause in place. He stated that fiscal note revisions would cut costs by \$693,000 for the biennium.

REP. BARDANOUVE moved that the Committee approve Amendments A,B,C, and D to HB 674. The MOTION was UNANIMOUSLY APPROVED by the Committee members.

REP. BARDANOUVE moved that HB 674 do pass as amended. The MOTION was UNANIMOUSLY APPROVED.

HB 676.

REP. QUILICI moved that the Committee pass on HB 676 for the day. The MOTION was UNANIMOUSLY APPROVED.

HB 688 and HB 691.

CHAIRMAN LUND stated that this would bring the bill to \$2,000,000. The MOTION as made by REP. QUILICI, FAILED, with 13 members voting no, one member voting aye and two members absent.

REP. QUILICI moved that HB 45 do pass in its original state. The MOTION was APPROVED with 13 members voting aye and two voting no. REP. LORY ABSTAINED.
