MINUTES OF THE HUMAN SERVICES COMMITTEE April 15, 1981

The Human Services Committee convened at 12:15 p.m. in Room 103 of the Capitol on April 15, 1981 with CHAIRMAN BUDD GOULD presiding. All members were present except Representatives Bergene, Keyser, Seifert, Conn and Metcalf. Those excused were Representatives Pavlovich and Menahan.

SJR 34

SENATOR HAGER opened the hearing on SJR 34, which requests an interim study of licensing laws regarding facilities that provide protective oversight, supervision, personal care, rehabilitation and health care to the young, disabled, infirm, or elderly of the state. He said that the Senate Human Services Committee had observed a duplication of services and efforts in this area and felt that a study might remedy the situation.

PROPONENTS:

JUDITH H. CARLSON, Deputy Director of the Social and Rehabilitation Services, said she had appeared at a number of "licensing" bills and has been frustrated at the number. She welcomed scrutiny given regarding licensing.

ROSE SKOOG, representing the Montana Nursing Home Association appeared in support of the bill, saying she had no amendments to offer.

WARREN BRASS, representing the Department of Health and Environmental Sciences (DHES) and appearing for George Fenner, who was unable to be there, said the department would like to offer the services of Dale Farmer to assist any staff that this resolution would create. He urged support of the bill.

DOUGLAS OLSON, legal counsel for the DHES, read written testimony (EXHIBIT I) favoring the bill.

OPPONENTS:

There were none.

QUESTIONS FROM THE COMMITTEE:

REP. BARDANOUVE asked for a definition of a "swing bed" spoken of in the bill. MR. OLSON said it was the double use of a bed as a result of need--it could be either a bed for nursing home care, or for regular hospital use.

REP. WINSLOW asked if hospitals are included in the study.

SENATOR HAGER said they were not specifically mentioned but he felt they would possibly be included. REP. GOULD felt the inclusion of "swing beds" would automatically include hospitals.

MR. BRASS of the DHES agreed.

SENATOR HAGER told the committee that another study was made in 1976, but that it did not include areas of licensure addressed by this bill. He then closed the hearing.

EXECUTIVE SESSION

REP. NILSON moved that SJR 34 DO PASS. The motion was seconded and PASSED UNANIMOUSLY.

REP. SIVERTSEN was assigned to CARRY THE BILL.

The meeting adjourned at 1 p.m.
