

MINUTES OF THE MEETING
STATE ADMINISTRATION COMMITTEE
MONTANA STATE SENATE

January 19, 1981

The eighth meeting of the Senate State Administration Committee was called to order by Senator Pete Story, Chairman, on the above date, in Room 442 of the State Capitol Building at 10 a.m.

ROLL CALL: All members were present.

ACTION ON SENATE BILL 81: Senator Towe moved that this bill DO PASS. This motion failed. Senator Kolstad moved that Senate Bill 81 DO NOT PASS. This passed by reverse vote on the first motion.

ACTION ON SENATE BILL 82: The subcommittee, Senators Ryan and Johnson, reported that they recommend a DO NOT PASS on this bill because people in the Public Health Corps are being paid while going to school, and this would give them double pay. Senator Ryan moved that this bill No. 82 DO NOT PASS. It passed by unanimous vote.

ACTION ON SENATE BILL 86: Senator Ryan moved that this bill DO NOT PASS; motion failed. Senator Hafferman moved that amendments be added, and the bill AS AMENDED, DO PASS. Motion carried. The amendment was in the title, line 7, following "PETITION" and inserting "AND TO LIMIT TO FIFTEEN PER CENT THE SIGNERS INCLUDED FROM ONE DISTRICT". This also occurred in lines 9 and 11 in page 2.

ACTION ON SENATE BILL 87:

Discussion on Senate Bill 87: Senator Towe proposed that the matter could be regulated with the election judge having full authority to make sure the individual sets up his table so that he does not disturb people before they vote. This could be controlled by the judge.

Senator Hafferman said there should be no politics in the polls! He feels they should pass the bill.

Senator Kolstad said regarding Senator Towe's remarks that perhaps it is not constitutional.

Senator Kolstad moved that this bill DO PASS. This passed by majority vote.

ACTION ON SENATE BILL 92: Senator Ryan moved the bill DO NOT PASS. It passed by majority vote.

ACTION ON SENATE BILL 93: Senator Towe moved that this bill DO NOT PASS. It passed by majority with Senator Ryan abstaining.



ACTION ON SENATE BILL 104: Senator Towe moved that this bill DO NOT PASS. This passed by majority vote.

ACTION AN SENATE BILL 105: Senator Hafferman moved that this bill DO PASS. There was a substitute motion by Senator Towe with some amendments in the body of the bill. This did not pass. The original motion by Senator Hafferman to PASS was voted on again with the amendments in the title following "CIRCULATE", insert "A BALLOT ISSUE". Senate bill 105 passed AND, AS SO AMENDED DO PASS by majority vote, with Senator Towe voting "NO".
