MINUTES OF THE MEETING SENATE COMMITTEE ON EDUCATION AND CULTURAL RESOURCES FEBRUARY 2, 1981

The Senate Committee on Education and Cultural Resources met Monday, February 2, 1981, in Room 402 of the Capitol Building. Senator Bob Brown, Chairman, called the meeting to order at 1:00 p.m.

ROLL CALL

Committee members present were Senators Brown, Smith, Mazurek, Thomas, McCallum, Severson, Haffey, Hammond, and Blaylock.

ACTION ON SENATE BILL 154

The members of the committee discussed the proposed amendments to the bill (attachment #1).

Senator McCallum moved to add "and" following subsection (d). The motion carried unanimously.

Senator Mazurek moved to amend subsection (d) to read "(c) by providing a copy of the notice in time for publication prior to the meeting in a weekly newspaper of general circulation in second-class and third-class districts;". The motion carried unanimously.

Senator Blaylock moved to adopt the amendments as amended. The motion carried unanimously.

After discussion regarding inclusion of provisions for emergency meetings, Senator Blaylock moved to delay action on the bill until Wednesday, February 4, so proposed amendments can be submitted re emergency meetings. The motion carried unanimously (Senator Smith absent).

ACTION ON SENATE BILL 125

Senator Thomas moved to amend line 16 by striking \$600,000 and inserting \$150,000 and line 21 by striking \$600,000 and inserting \$175,000. The motion carried unanimously with Senator Smith absent.

Senator McCallum moved Senate Bill 125 DO NOT PASS AS AMENDED. The motion carried unanimously.

Senator Hammond moved to reconsider action on Senate Bill 125. The motion carried on a roll call vote (attachment #2). Page 2 Senate Committee on Education and Cultural Resources February 2, 1981

Insert: "Notice of meetings of board of trustees of a school district. (1) The board of trustees of a school district as defined in 20-6-101 shall give notice of regular meetings in the following manner:

(a) by posting a notice of the meeting at least 48 hours before the meeting on the main door of the building in which the school district administration office is located. If there is no such administration office, the notice must be posted on the main door of the principal school building in the district;

(b) by providing a copy of the notice at least 48 hours before the meeting to a daily newspaper of general circulation in first-class districts;

(c) by providing a copy of the notice at least 48 hours prior to the last publication deadline of a weekly newspaper of general circulation in second-class and third-class districts;

(d) by including in the notice of the meeting the place, time, and intended agenda of the meeting;

(e) by delivering written notice of the meeting at least 48 hours before the meeting to any individual who is scheduled to be the subject of discussion or action at any meeting.

(2) The board shall give notice of special meetings in the manner provided in (a), (d), and (e) of subsection (1).

(3) At a meeting of the board of trustees, the trustees may take action only on the agenda items that were announced in the notice required by subsections (1) and (2), except that the board may act on nonpersonnel-related items if such items are raised spontaneously in good faith.

Section 3. Codification Instruction. Section 2 is intended to be codified as an integral part of Title 20, chapter 3, part 3, and the provisions of Title 20, chapter 3, part 3 apply to section 2."
