ACTION ON S.B. 409
" CREATING A WATER DEVELOPMENT PROGRAM..."

This meeting was called on recess of the Sanate to make a determination as to whether S.B. 409 is an appropriation/revenue bill.

Senator Galt explained that S.B. 409 will establish an earmarked water-development account to be funded by revenues from state water projects and 30 percent of the interest income from the Resource Indemnity Trust Account. Currently, revenues from state water projects are deposited to the general fund, and interest from the Resource Indemnity Trust Account is available for discretionary appropriation to natural-resource projects. Further, he stressed that this bill sets up the machinery for the trust account and there will have to be spother bill to appropriate the money. He feels this is not a money bill.

Senator Blaylock moved that the bill comes within the context of an appropriation or revenue bill, therefore, there is no necessity for it to be acted on within the 45th day deadline, and re-refer it to Senate Taxation Committee.

There being a division, a roll call vote was taken with Hazelbaker, Turnage, Smith, Blaylock, Norman, and Stephens voting yes; Kolstad, Galt, Graham, and Boylan voting no. Motion carried.

The meeting adjourned at 5:30 p.m.
