

MINUTES OF THE MEETING
TAXATION COMMITTEE
MONTANA STATE SENATE

March 16, 1981

The 48th meeting of the committee was called to order at 8:00 p.m. in Room 415 of the State Capitol Building, Chairman Pat Goodover presiding.

ROLL CALL: All members present except for Senator Healy.

DISPOSITION OF HOUSE BILL 111:

Senator Bob Brown recommended that HB 111 BE NOT CONCURRED IN. The motion carried unanimously.

DISPOSITION OF HOUSE BILL 112:

Senator Elliott recommended that the bill BE CONCURRED IN. Senator Ochsner said he had talked to Representative Lund and he had said if the county commissioners wanted it to have the language in the bill, it was all right.

Senator Bob Brown moved that HB 112 BE CONCURRED IN as it is. The motion carried with Senators Norman, McCallum and Manley dissenting. Senator Ochsner will carry the bill.

DISPOSITION OF HOUSE BILL 176:

A motion was made to give a BE CONCURRED IN to House Bill 176. The motion carried with Senators Crippen and Goodover dissenting. Senator B. Brown will carry.

DISPOSITION OF HOUSE BILL 462:

Senator S. Brown moved that HB 462 BE CONCURRED IN. The motion was passed unanimously. Senator Elliott will carry the bill.

DISPOSITION OF HOUSE BILL 63:

Senator Towe made several suggested amendments; Senator S. Brown moved adoption of the amendments. Senator Towe moved a second amendment. The amendment was discussed and it was decided to move HB 63 to the bottom of the committee board while amendments are clarified.

DISPOSITION OF HOUSE BILL 121:

Senator Eck made a motion to give HB 121 a BE CONCURRED IN recommendation. She felt this bill would give security to the counties who feel we are badgering them. She didn't think the Coal Board would be allocating money. The interest would go on to the trust fund anyway. Senator Towe disagreed.

Senator S. Brown asked if we weren't interfering with HB's 610,

and 611 if we pass this bill?

TOWE: Thought it could. In their projections I don't think they included any reversions from the coal fund. On the interim finance committee it didn't seem like the coal board was hurting for dollars. I have had my aide call the coal companies to get figures of increased employment and there is very little new employment, so the need might be down for this year. They will probably have plenty of money with the 17 million dollars this year.

Senator Bob Brown moved that HB 121 BE NOT CONCURRED IN. The motion passed and Senator B. Brown will carry the bill.

DISPOSITION OF HOUSE BILL 411:

Senator Elliott made a motion that HB 411 BE CONCURRED IN. The motion carried unanimously. Senator Elliott will carry.

DISPOSITION OF HOUSE BILL 415:

House Bill 415 was moved to the bottom of the board.

DISPOSITION OF HOUSE BILL 433:

Senator Elliott moved that the bill BE CONCURRED IN without amendment.

Senator Elliott moved the bill BE CONCURRED IN as originally written. The motion failed to pass. The secretary was asked to reverse the vote to show a BE NOT CONCURRED IN by the 7-6 margin. Senator Goodover will carry the bill.

DISPOSITION OF HOUSE BILL 435:

Senator Elliott moved that HB 435 BE CONCURRED IN.

There was some discussion about the fact that nothing has indicated that we have those penalties against corporations.

The question was called on the motion and the vote was unanimously in favor of it. Senator Elliott will carry the bill.


DISPOSITION OF HOUSE BILL 447:
