April 3, 1981

The Senate Rules Committee met Friday, April 3, 1981 in Room 331 of the State Capitol. Senator Stan Stephens, Chairman, called the meeting to order at 3:15 p.m.

ACTION TAKEN ON S.B. 15

"AMENDING 17-5-102 TO ELIMINATE INTEREST RATE CEILING ON POLITICAL SUBDIVISION BONDS".

This meeting was called for the purpose of correcting an oversight of the Senate Taxation Committee. The original copy of Senate Bill 15 removed the interest ceiling on bonds issued by political subdivisions of the state. The Taxation Committee decided that it would be best to expand this bill to amend each section in the Code relating to the sale of government bonds and requested the Legislative Council to draft a substitute bill to do this (LCSB 0015). From then on the committee worked solely from this substitute bill but did not amend the original bill to replace the original language with the substitute language. The substitute bill passed the committee amended, passed both houses, and was on its way to enrolling when this error was discovered. It was then sent to the Senate Rules Committee on April 3, 1981. An amendment was drafted to replace the original bill with the substitute bill.

Senator Turnage moved that S.B. 15 be amended on Page 1, line 4 following "ENTITLED:" strike remainder of bill in its entirety. Insert everything following the word "ENTITLED:" Page 1, line 4, contained in LCSB 0015/05. Motion carried.
