MINUTES OF MEETING SENATE JUDICIARY COMMITTEE APRIL 16, 1981

The fifty-fourth meeting of the Senate Judiciary Committee was called to order by Mike Anderson, Chairman, on the above date in Room 331, at 10:00 a.m.

ROLL CALL:

All members were present except Senators B. Brown and O'Hara, who were excused.

CONSIDERATION OF HOUSE JOINT RESOLUTION 64:

TO REQUEST AN INTERIM STUDY OF ALL ASPECTS OF MONTANA'S LAWS RELATING TO EMINENT DOMAIN.

Representative Jacobsen, District 1, presented the Resolution, saying that a real need exists to bring industry together with the rest of the state to clarify the usage of eminent domain. He said that the purpose of the bill is not to make eminent domain easier or more difficult, but only to clarify it and make it more fair.

Steve Doherty, representing the Northern Plains Resource Council, testified in support of the Resolution, saying that this study is long overdue because of the recent rapid increase in the number of eminent domain cases.

Senator Halligan questioned the wording at the top of page 2, suggesting that the underlined language be replaced with "the use of eminent domain."

Representative Jacobsen said that he would have no trouble accepting such a change, but that the time limit made any amending difficult to accomplish at this time.

DISPOSITION OF HOUSE JOINT RESOLUTION 64:

Senator Olson moved that House Joint Resolution 64 BE CONCURRED IN. His motion passed unanimously
