MINUTES OF THE MEETING TAXATION COMMITTEE MONTANA STATE SENATE

April 23, 1981

The 70th meeting of the committee was called to order at 9:05 a.m. in Room 415 of the State Capitol Building, Chairman Pat Goodover presiding.

ROLL CALL: All members were present except for Senators S. Brown and Norman.

CONSIDERATION OF HOUSE BILL 640:

"AN ACT PROVIDING FOR ASSISTANCE TO FARMERS, RANCHERS, AND BUSINESSMEN ENGAGED IN AGRICULTURAL ACTIVITIES BY ESTAB-LISHING THE MONTANA AGRICULTURAL DEVELOPMENT BOARD; AUTHOR-IZING THE ISSUANCE OF REVENUE BONDS FOR ACQUISITION OF AGRICUL-TURAL LAND, LIVESTOCK, BUILDINGS, OR IMPROVEMENTS; PROVIDING CERTAIN INCOME TAX INCENTIVES TO INDIVIDUALS WHO SELL OR RENT AGRICULTURAL LAND TO BEGINNING FARMERS; <u>CREATING AN AGRICUL-</u> TURAL ACCOUNT IN THE BOND PROCEEDS AND INSURANCE CLEARANCE FUND AND APPROPRIATING MONEY DEPOSITED IN THE ACCOUNT; AND AMENDING SECTION 15-30-121, MCA."

Senator Towe presented amendments to the bill. He read through them for the committee. The proposed amendments are incorporated as part of these minutes, Attachment #1.

Senator Towe moved adoption of the amendments. The motion carried with Sen. Hager dissenting.

Sen. Towe then moved the bill BE CONCURRED IN, as amended. The roll call vote taken resulted in a 6-6 tie. The bill was killed.

The meeting was adjourned at 10:00 a.m.

but not limited to a local committee of the farmers home administration, the production credit association, the federal land bank, private lenders, or other similar organizations.

(2) Applications may be submitted by individuals, partnerships, associations, or joint ventures. All persons involved in the application must meet the requirements of subsection (1). Corporations, as defined in 35-1-102, may not apply.

NEW SECTION, Section 11. Evaluation of applicants. (1) The authority shall by rule establish:

(a) rules for soliciting and evaluating applications from qualified Montana citizens; and

(b) a point system for evaluating the applicants, considering the following criteria:

(i) the applicant's net worth, which may not exceed \$100,000;

(ii) the applicant's access to livestock and machinery;

(iii) the applicant's inability to secure adequate financing for purchase of agricultural land from other sources at an interest rate that will allow a reasonable prospect for repayment;

(iv) the applicant's training and experience in agriculture;(v) the applicant's prospects for succeeding in an agricul-

tural operation on the land proposed for purchase; and

(vi) any other factors it may prescribe.

(2) The authority shall select the best qualified and most deserving applicant from among those applying for loans.

(3) The authority may seek the advice of such lenders as the farmers home administration, the production credit association, the federal land bank, private lenders, and similar organizations in Montana and coordinate its loan program through such organizations including assistance in screening applicants and servicing the loan."
