MINUTES OF MEETING OF SENATE JUDICIARY COMMITTEE

The sixth meeting of the Senate Judiciary Committee was called to order at 11:15 a.m., June 26, 1982, in Room 331 of the State Capital Building with Chairman Mike Anderson presiding.

ROLL CALL: Roll call found all of the members present with the exception of Sen. Bob Brown.

Sen. Mazurek stated the Legislative Council had prepared some amendments for Senate Bill 4, by Sen. Ryan, and already heard by the committee at a Joint Senate-House meeting previously.

The amendments were distributed to committee members and discussed by them. Sen. Mazurek then Moved Amendments for SB4 be adopted. His motion carried.

Sen. Steve Brown then Moved Senate Bill 4, As Amended Do Pass. Before a vote, the committee asked for a question during which time they discussed the bill again. The bill dealt with the providing of information, histories, background, etc., by parole and probation officers, for the various justice, city and municipal courts. Sen. Ryan had stated that often the work of the parole officers were delaying tactics only, and constituted a real burden on the officers as far as using their time. The members pointed out two major reasons for their adverse feelings toward the bill: 1) The J.P.'s of the state had not had the opportunity to hear the bill at a public hearing and thus had not had a chance to speak either for or against it; 2) The . committee felt that this particular bill did not fit into the prison crisis situation, the purpose of this special legislative session.

The members asked if this is a particular problem in other counties, as well as Cascade County. A number of the committee members had called J.P.'s in their area to question their opinions, and it appeared this situation was peculiar to Cascade County only, as far as present information.

Sen. Mazurek then made a Substitute Motion that SENATE BILL 4, As Amended, DO NOT PASS. A roll call vote was taken which resulted in 6 Yes, 3 No, thus his motion was carried and the bill goes out of committee with that recommendation.

Following disposition of this bill Chairman Anderson adjourned the meeting.
