FISH AND GAME COMMITTEE

January 20, 1983

The meeting was called to order by Chairman Les Nilson in room 420 of the Capitol Building at 12:30 p.m., with all members present.

Chairman Nilson opened the meeting to an <u>EXECUTIVE SESSION</u> on House Bills: 94, 101, and 104.

HOUSE BILL 94

Rep. Phillips moved House Bill 94, DO PASS.

Rep. Ellison moved the amendments to House Bill 94, DO PASS, The motion carried unanimously. (see exhibit 1)

Rep. Mueller moved the statement of intent, DO PASS, the motion carried unanimously. (see exhibit 2)

HOUSE BILL 101

Rep. Jensen moved House Bill 101, DO NOT PASS.

Rep. Devlin stated there is a time when we are going to have to address this problem. A certain percentage should go to the development and maintenance of the parks. This percentage would be taken off the top of the budget for the next year.

Rep. Swift said I would support considering an amendment where you would guarantee that some funding goes to operation and maintenance or a value offset proposal.

Chairman Nilson turned the chair over to Vice Chairman, Gary Spaeth.

Vice Chairman Spaeth announced that executive action would be deferred on House Bill 101 until Tuesday, January 25.

HOUSE BILL 104

Rep. Mueller commented that nobody that testified had a quarrel with some sort of a cap. The problem was what that cap should be. I feel very strongly that we do need a cap. This bill serves a very useful purpose. Under this law, the Fish and Game could appraise these sites and make recommendations to the legislature as to whether it is worth the money or has some kind of value to the public as a whole. As the amount of money grows, we are going to be more prone to submit to the pressure of organized groups.

Rep. Jensen said I believe very strongly in the process where the citizens of the state can submit a plan before the legislature for the money. Creative tendencies ought to be encouraged for the people with this ability.

Rep. Daily stated if you go over the \$15,000,000. cap, you are just passing it on to the next legislature. There were no proponents to the bill, I think we ought to take the opponents to the bill into consideration.

Rep. Devlin said the more money that is in the fund, the more proposals we will have, We are putting a tremendous job on the long-range building committee to make these decisions.

Rep. Jensen commented the most important data is the interest that will be raised.

Rep. Swift moved to explore three categories, \$20,000., \$30,000., and \$50,000., the motion passed unanimously.

The meeting was adjourned at 1:30 p.m.
