

MINUTES OF THE MEETING OF THE HOUSE EDUCATION AND CULTURAL
RESOURCES COMMITTEE
February 19, 1983

The meeting was called to order at 4:50 p.m. by Chairman Daily. Roll call was taken and all committee members were present.

This meeting was an executive session to take action on HB 791.

HOUSE BILL 791

House Bill 791 is an act providing a pay schedule for institutional teachers for fiscal year 1984; providing for the adjustment of this schedule for succeeding fiscal years; prohibiting a public employer and an exclusive representative of institutional teachers from bargaining collectively with respect to wages.

REPRESENTATIVE PECK moved HB 791 BE TABLED.

REPRESENTATIVE PECK said he realizes contract negotiations may not be going well but feels if HB 791 is passed, the legislature may get involved in the negotiations process.

The motion was voted on and PASSED. All committee members voted yes except Representatives Daily, Kennerly and Schye.

HOUSE BILL 395

REPRESENTATIVE SANDS moved to RECONSIDER PREVIOUS ACTION TAKEN ON HB 395.

CHAIRMAN DAILY said he is opposed to that motion. He said there had been a motion by Representative Jensen, on the floor of the House, that HB 396 be taken off the table and put on second reading. The motion failed by a considerable margin. Chairman Daily said he felt it would be a waste of time to try and debate the bill again.

REPRESENTATIVE PECK said he had mixed emotions on the bill but felt the bill should be taken off the table. He said there is a problem and the fate of HB 395 should be left up to the full House body to make a decision.

REPRESENTATIVE KADAS said he thinks it is too late to try to debate this bill again. There is not enough time to bring the bill to the floor of the House and have the full body make a decision.


REPRESENTATIVE EUDAILY said he feels the subcommittee did as well as can be expected on this bill. He said he would like to


have an interim study committee to study the problem of tenure.

REPRESENTATIVE NISBET said he agreed with Representative Eudaily. He said this is too complex of a problem to bring to the floor with the time we have remaining.

The motion was voted on and FAILED. A roll call vote was taken and all committee members voted no except Representatives Donaldson, Hammond, Hannah, Kitselman, Miller, Peck and Sands, who voted yes.

The meeting was adjourned at 5:00 p.m.
