

MINUTES OF THE MEETING OF THE HOUSE AGRICULTURE,
LIVESTOCK AND IRRIGATION COMMITTEE, MARCH 16, 1983

The meeting was called to order by Chairman Jacobsen on Wednesday, March 16, 1983 at 12:30pm, in Room 129, State Capitol. All members were present with the exception of Representatives Howe and Ellerd who were excused.

EXECUTIVE SESSION

SENATE BILL 259. REP. SCHULTZ moved the bill Be Concurred In and then moved the amendments to the bill including clerical renumbering of sections and other amendments.

REP. SPAETH said the penalty fee was not commensurate with costs. Mr. John MacMaster, Legislative Council Attorney, told the Committee, lines 12 and 13 on page 34, following "established by" could be amended to read "fee in an amount established by a rule of the Department" and the Statement of Intent could be changed accordingly, on line 10 by inserting "or penalty" after "fee" and on line 8 by inserting "or penalties".

REP. SCHULTZ restated his motion to included the amendments proposed by Mr. MacMaster. The motion was seconded by Rep. Hanson and unanimously approved by the Committee.

REP. SCHULTZ moved the bill Be Concurred In as Amended.

REP. SPAETH told the Committee lines 2-3, page 15 and lines 19-20, page 16 are inconsistent, adding lines 2-3 on page 15 should be stricken from the bill. Mr. MacMaster agreed with Rep. Spaeth. Mr. Les Grahsm, Department of Livestock, advised the bill would be more consistent if "exempt" through "less" were stricken from lines 2-3, page 5 of the bill.

REP. HOLLIDAY moved the bill be so amended. Rep. Lybeck seconded the motion which was unanimously approved.

REP. HOLLIDAY moved the Committee reconsider its action on the Statement of Intent, whereby language was added pertaining to a penalty. Rep. Ernst seconded the motion, which was unanimously approved.

REP. HOLLIDAY moved the Statement of Intent be amended to read (following line 11): "The Legislature intends that a penalty be established by rule for failure to apply for renewal of a license required by 81-22-208. The penalty should be sufficient to encourage renewal of licenses." The motion was seconded by Rep. Ernst and unanimously approved.

In. Rep. Lybeck seconded the motion which was unanimously
approved.

SENATE BILL 415. REP. SPAETH moved the bill Be Concurred
In. Rep. Saunders seconded the motion.

MR. JOHN MACMASTER, Legislative Council Attorney, advised
the Committee page 6, line 7, prior to "package", "any"
should be inserted since the bill is presently too vague
as to who is to label a package, parcel or lot.

REP. SCHULTZ asked if the language would cover repackaging.
Mr. MacMaster replied it would.

REP. SPAETH said the language was awkwardly worded before
and the original amendment was to make certain a person
offering seed for sale would be responsible.

CHAIRMAN JACOBSEN asked if the bill would eliminate
bartering. Rep. Spaeth suggested insertion of language
to address trade.



REP. HOLLIDAY moved, following "Any" on page 6, line 7
