He commented that the resolution, a study resolution, which would require an interim study of options and alternatives for investing state retirement funds, coal tax trust funds, and other cash funds, was complicated and he didn't know if this could be done.

METCALF moved that HJR 4 be tabled. RAMIREZ said he had a resolution to study pensions and that he thought this resolution could be a part of a study package. METCALF commented that he thought the state had one of the best Board of Investments around and that a study was unnecessary.
