

MINUTES OF THE MEETING
STATE ADMINISTRATION COMMITTEE
MONTANA STATE SENATE

January 6, 1983

The meeting of the State Administration Committee was called to order by Chairman Pete Story on January 6, 1983 at 10:00 a.m. in Room 331, State Capitol.

Leona Williams is secretary to the committee and DAVE COGLEY was introduced by the chairman as Staff Attorney to the committee. Mr. Cogley presented the committee with a handout, EXHIBIT 1, stating his functions.

ROLL CALL: Roll was called and all members were present, although Senator Hammond and Senator Tveit were late due to another committee meeting.

SENATE JOINT RESOLUTION NO. 3 was introduced by SENATOR HIMSEL of District 9. This resolution is "A JOINT RESOLUTION OF THE SENATE AND THE HOUSE OF REPRESENTATIVES OF THE STATE OF MONTANA REQUESTING THE DEPARTMENT OF INSTITUTIONS TO GIVE THE NAME "BENNETT HALL" TO THE NEW WING AT THE MONTANA VETERANS' HOME IN COLUMBIA FALLS...".

PROPOSERS were called for. SENATOR ELLIOTT spoke as a proponent stating that he was Dr. Bennett's accountant and testified to the faithfulness and devotion of Dr. Bennett to the hospital.

DOB DURKEE, representing the Veterans of Foreign Wars, testified in favor of Joint Resolution No. 3.

CURT CHISHOM, Deputy Director of the Department of Institutions also spoke as a proponent.

There being no further proponents and no opponents, questions were asked for of the committee.

SENATOR HIMSEL closed on SJR No. 3 asking the committee's support.

ACTION ON SENATE JOINT RESOLUTION NO. 3: SENATOR TOWE MOVED
THE SENATE JOINT RESOLUTION NO. 3 do pass. The motion was
seconded and PASSED UNANIMOUSLY.

SENATE JOINT RESOLUTION NO. 6: SENATOR JOSEPH MAZUREK
introduced Senate Joint Resolution No. 6, "TO NAME THE NEW
DIVISION OF WORKERS" COMPENSATION BUILDING THE "MARGARET
"PEG" CONDON BUILDING". He stated that Peg Condon is well
deserving of this honor serving faithfully for many years
and that it be well to honor someone still living.

PROPOSERS were called.

GARY BLEWETT, current Administrator of Workmen's Compensation,
testified recommending and asking the committee's support of
this Resolution. He stated that Peg Condon has served under
nine of twelve administrators and that her knowledge has been
advantageous to them and all of those in the department.

NORM GROSFIELD spoke as a proponent and as a former administra-
tor of Workmen's Compensation from January 1975 to July 1979.
He also spoke for LARRY ZANTO who is absent from the state and
wished to express his support. A letter was read by Mr.
Grosfield from ROBERT F. SWANBERG (EXHIBIT 2) which praised
Margaret "Peg" Condon's 50 years of service to the department.

SENATOR DAVE FULLER, spoke as a proponent who had the honor
of working with Peg Condon from 1977 to 1981 when he served
as commissioner.

TOM SCHNEIDER, Executive Director of the Montana Public Employees
Association spoke in behalf of the employees recommending this
Resolution.

There being no other proponents or opponents, PHILL HAUCK,
State Architect spoke on behalf of the Board of Examiners as
a neutral, stating that there has never been a set procedure
in naming buildings and was wondering if the Legislature should
establish some guidelines.

SENATOR TOWE asked if the Board of Examiners would be willing
to come up with these guidelines and Mr. Hauck said they would.

The meeting closed on SENATE JOINT RESOLUTION NO. 6.

NO ACTION was taken

SENATE JOINT RESOLUTION NO. 4: SENATOR JEAN TURNAGE introduced Senate Joint Resolution NO. 4, "EXPRESSING SUPPORT FOR THE DEVELOPMENT OF THE MANSFIELD CENTER FOR PACIFIC AFFAIRS:", and will put into place the cooperative program that relates to the existing Maureen and Mike Mansfield Center at the University and in future effort, be known as the Mansfield Center for Pacific Affairs. A purposed amendment by Turnage was distributed EXHIBIT 3.

PRESIDENT BUCKLEY, President of the University of Montana then spoke to the committee in support of this resolution. He stated that they have had a center that is essentially academic which focuses on two areas of work; one, Asian studies and two, ethics in public affairs. The ambassador has been a close follower of the development of the center and as they work through the Board of Regents, they will this spring, have a filed, detailed approval of the program structure. He stated that, with the advent of a second structure, Mansfield Center for Pacific Affairs, the ambassador has expressed his wishes that these two centers work together. President Buckley said they each sent a delegate to Tokyo over a year ago who met with the ambassador and from that session they developed the Maureen and Mike Mansfield Foundation, an umbrella with two purposes; one is to do the fund raising for each of the centers and second to assure the coordination of those two activities.

President Buckley told the committee that the changes in the resolution has simply taken a resolution that specifically refers to the Mansfield Center for Pacific Affairs and ask that the Legislature establish as a matter of record, their support to the nation and the two programs that are to be supported by the Foundation. President Buckley referred the committee to the booklets, EXHIBIT 4.

GARY BUCHANAN, Director of the Department of Commerce, spoke in behalf of Governor Schwinden and the organization and stated that they rise to support the resolution. He stated that in some future date the governor would examine the potential in finances from the state.

There being no further proponents and no opponents, questions were called for from the committee.

SENATOR TOWE asked President Buckley if this new Center would require additional space.



RE: Staff Attorney Functions
DATE: January 3, 1983

I have been assigned to staff your committee during the legislative session and am available to do the following:

- 1) review proposed legislation and advise the committee as to constitutionality, internal consistency, possibility of conflict with or duplication of existing provisions, and compliance with other bill drafting provisions such as grammar, punctuation, word choice, and sentence structure;
- 2) research other states' laws pertaining to a given bill upon request of a committee member;
- 3) assist the committee or individual member in obtaining data or any pertinent information from governmental entities pertaining to bills under deliberation;
- 4) draft proposed amendments upon request of individual committee members prior to committee action on a given bill;
- 5) review all amendments adopted by the committee to insure that appropriate language is used to accomplish the intended result, and that corresponding changes necessary to reflect the effect of the amendment are made in the rest of the bill (e.g. title changes, section or subsection renumbering, grammar, punctuation, etc.)
- 6) draft proposed amendments to be moved on second reading upon request of any committee member;
- 7) review rough drafts of committee minutes to assist the secretary in accurately reflecting the deliberations of the committee;

- 8) draft statements of legislative intent or obtain drafts from state agencies when directed by the committee;
- 9) draft committee bills when requested by the committee;
- 10) attend subcommittee meetings when assigned by the chairman to perform the appropriate functions listed above; and
- 11) attend conference committee or free conference committee deliberations as invited to perform the appropriate functions listed above.

Please feel free to call on me at any time, either during committee meetings or downstairs in room 117. Because we are still drafting legislation during the first few weeks of the session, my availability to the committee may be somewhat limited at first; but please bear with me. I look forward to working with you.

Dear Norman:

I am informed that a bill has been introduced which proposes to name the new Workers Compensation Building in honor of Margaret Condon, who has been associated with the agency for nearly 50 years. On the basis of personal knowledge of Mrs. Condon's contribution to Workers Compensation during her long career in this field, I wholly endorse this proposal.

This knowledge began in 1952, when I was appointed by Governor John Bonner to the position of Chairman of the Industrial Accident Board, the agency which preceeded the present Division of Workers Compensation. Sixteen years in this capacity, through the terms of Governors Aronson, Nutter and Babcock enables me to fairly state reasons why this honor should be bestowed on Mrs. Condon.

She began her career during the chairmanship of J. Burke Clements in the early thirties, when she was hired as a clerk. By the time I arrived on the scene in late 1952, she had acquired a considerable knowledge of the procedures of the claims department, which enabled her to render invaluable assistance to me and, no doubt, to my successors during our periods of learning the daily workings of the agency.

Mrs. Condon's remarkable memory, ability to master detail, and to stimulate the energies of subordinates required that she be given responsibilities commensurate with these capabilities. As claims supervisor and later as executive secretary to the board, she fully justified our confidence in her.

It is altogether fitting and proper that her long service to the State of Montana, and contribution to good government should be acknowledged by giving the new building her name.

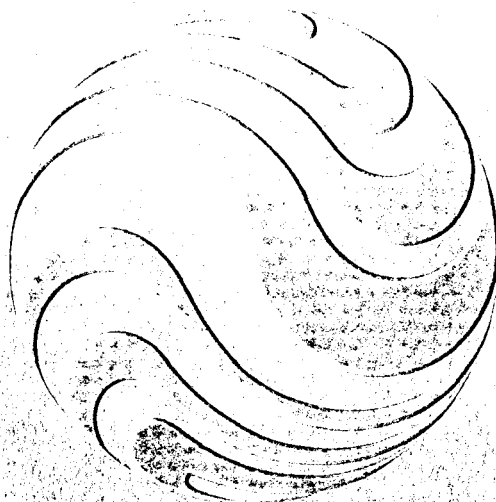
