## MINUTES OF THE MEETING LEGISLATIVE ADMINISTRATION COMMITTEE MONTANA STATE SENATE

January 19, 1983

The fourth meeting of the Legislative Administration Committee was called to order by Senator Kolstad, Chairman, at 10:00 a.m. on the above date in Room 415 of the Capitol building.

ROLL CALL: All committee members were present except Senators Graham and McCallum who were excused.

CONSIDERATION - SENATE BILL NO. 20: An act to remove the requirement that the Capitol press room be located on the 3rd floor, adjacent to the Senate chambers.

Senator Goodover, author of SB 20, appeared before the committee in support of his bill. He said that this bill was requested by the Legislative Council and that, as the law now reads, it says it has to be on the 3rd floor in the building adjacent to the assembly hall of the Senate and it should be used as a joint press room. He also said that this bill would allow the architects to move it to a different location in the Capitol building, which is in the plans now. Senator Mazurek asked if the press had contacted him on this bill. Sen. Goodover answered: "No, but we are within the law."

Diana Dowling, Executive Director of the Legislative Council, appeared before the committee and said that the architects had contacted her as well as some of the members of the legislature and said that the architects had the press room scheduled for a different location.

ACTION: Senator Kolstad called for a motion on SB 20. Senator Goodover suggested that maybe it should be placed on the Consent Calendar. Senator Mazurek moved that it be placed on the Consent Calendar. Senator Marbut seconded the motion which carried unanimously.

Senator Kolstad thanked the committee members and those present for attending the meeting. There being no further business before the committee, the meeting was adjourned.
