# MINUTES OF THE MEETING HIGHWAYS AND TRANSPORTATION MONTANA STATE SENATE

January 25, 1983

The meeting of the Highways and Transportation Committee was called to order by Chairman Mark Etchart on Thursday, January 25, 1983 at 1:00 P.M. in Room 410, State Capitol.

ROLL CALL: Roll was called. Present: Senator Etchart, Senator Hager, Senator Elliott, Senator Shaw, Senator Tveit, Senator D. Manning, and Senator Graham late. Absent: Senator Stimatz and Senator Daniels.

SENATE BILL NO. 212: Hearing commenced on Senate Bill No. 212, sponsored by Senator Dave Fuller, Helena. This is an act to generally revise aeronautics licensing requirements. It deals with ultralight planes and their registration. This bill revises the laws on regulation and licensing of aircraft. It provides specifically that owners of ultralight aircraft must register with Department of Commerce and changes the date for registration of aircraft each year from June 1 to March 1. The bill also requires that an airman's license must be issued or approved by the federal government.

Mike Ferguson, representing the Montana Aeronautics Division, spoke in support of Senate Bill No. 212. Under present Montana law, all Montana pilots and aircraft must register with the state their appropriate effective license, certificate, or permit issued by the U.S. Government. In as much as neither an ultralight pilot nor aircraft are issued a license, certificate, or permit by the U.S. Government, it is impossible to comply with Montana registration requirements.

Mr. Ferguson said this creates a serious problem for the ultralight people as some airports have banned their operations citing the fact that they are in violation of Montana law, and therefore, operating illegally. Both the ultralight and airport operators are faced with liability problems as this concerns the insurance protection.

Mr. Ferguson said the Federal Aviation Administration (FAA) has under review from the private section, including the ultralight industry, AOPA Air Safety Foundation, and the Experimental Aircraft Association, proposals on (1) a national ultralight registration program and (2) an ultralight pilot training and certification program. The FAA has announced that they will be "approving" one or more of these programs in January 1983. They key word is approved as this is really

the only change in the registration law. We are adding the words "or approved" by the U.S. Government. It is estimated that there are about 100 ultralight aircraft based in Montana. It is a rapidly growing industry. Senate Bill No. 212 will merely make it possible for the ultralight pilots and aircraft to register and thus be in compliance with existing Montana pilot and aircraft registration laws. The ultralight people are in support of this bill.

Senator Manning asked Mr. Ferguson how many ultralights were in the State at this time.

Mr. Ferguson replied there are somewhere between 100 and 200, we really don't know. There is one or two ultralights in every community.

Senator Elliott asked Mr. Ferguson if the FAA would recognize a permit that Montana issues.

Mr. Ferguson said no, the FAA is recognizing a permit that the industry is approving, through the air safety program and the Experimental Aircraft Association. We will review and approve one or more of these programs.

Senator Graham asked if the ultralights are taxed.

Mr. Ferguson said this bill will solve that problem. Before we can register the ultralight, they will have to show evidence of taxes being paid. They are subject to personal property tax, the same as any other aircraft. This new registration will require that they have identification on the ultralights.

Senator Hager asked if the ultralights operate from airports, or backyards.

Mr. Ferguson said they operate out of small fields and small airports. They can operate out of airports if they have the proper communication. They are restricted from certain control zones.

Senator Manning asked what capabilities the ultralights have.

Mr. Ferguson reported that under the new regulations, they cannot have stall speed faster than 25 knots, or about 24 miles per hour. They are restricted to only one passenger.

There being no further discussion, hearing on Senate Bill No. 212 was closed.

SENATE BILL NO. 55: Senator Hager reported that the bill has been handled in another bill that was introduced in the House, but wanted to check with Bill Romine about it first. He requested the bill sit in Committee until Thursday.

ACTION ON SENATE BILL NO. 212: Senator Elliott made the motion to amend Senate Bill No. 212 as follows:

1. Page 1, line 23.
Following: "before"
Strike: "June"
Insert: "March"

It was passed unanimously.

Senator Elliott made the motion that Senate Bill No. 212 DO PASS, as amended. The motion passed with all Senators voting aye accept Senator Shaw, who voted no.

ACTION ON SENATE BILL NO. 106: Senator Etchart gave a brief summary on Senate Bill No. 106. He told the committee this bill triples the fines and also; on Page 3, line 5, states that no fine may be suspended. The trucking and logging industry supports the bill, but I think there are a lot of little independent truckers out there that would be put out of business by a \$3,000 fine.

Senator Shaw made the motion that Senate Bill No. 106, as amended, DO NOT PASS.

Senator Elliott made a substitute motion that the fines be doubled instead of tripled. The motion passed with all Senators present voting aye.

Senator Hager made the motion to strike on Page 3, lines 5 and 6. The motion carried with all Senators present voting aye.

Senator Elliott made the motion that Senate Bill No. 106 as amended DO PASS. The motion passed with the following Senators voting aye: Senator Hager, Senator Elliott, Senator Tveit, Senator D. Manning. Those Senator's voting no: Senator Etchart, Senator Shaw, and Senator Graham.

HOUSE BILL NO. 87: Hearing commenced on House Bill No. 87, introduced by Representative Dozier, Billings. Representative Dozier told the committee this is an act allowing the driver of an overtaken vehicle to travel on the shoulder of a two-lane highway until he is passed if it is safe to do so. The idea for this bill came when I was touring Canada, and discovered this is a common practice there and works well.

Gar Munson, Highway Patrol told the committee they support this bill. The Highway Patrol has no problem with movement to shoulder and back. As this bill stands right now, the Highway Patrol has no problem with it.

There being no further proponents, opponents, or questions from the committee the hearing on House Bill No. 87 was closed.

ACTION ON HOUSE BILL NO. 87: Senator Shaw made the motion that House Bill No. 87 BE CONCURRED IN. Senator Graham seconded the motion. The motion passed with all Senators present voting aye.

ADJOURN: There being no further business before the Committee, the meeting was adjourned at 1:55 p.m.
