# MINUTES OF THE MEETING LEGISLATIVE ADMINISTRATION COMMITTEE MONTANA STATE SENATE

January 27, 1983

The sixth meeting of this committee was called to order by Senator Kolstad, Chairman, at 11:00 a.m. in Room 415 of the Capitol building on the above date for executive action on Senate Resolution 3.

ROLL CALL: All committee members were present at this meeting.

EXECUTIVE ACTION: Senator Graham moved that Senate Resolution 3 BE ADOPTED. Senator McCallum seconded the motion.

Senator Kolstad asked if there were any questions on SR 3 before the committee voted. Senator Marbut asked if the Senate could not spend the money on this project now and not make a commitment, saying that he just doesn't think they should spend the money on the changing of the Senate chambers. Senator Graham said that the money has to be spent because the bonds have been sold, and that we have to "go all the way". Senator Marbut then asked if we can not spend the money this year. Senator Mazurek said that we could not do this.

At this time, Senator Kolstad asked for a roll call vote on Senate Resolution 3. The secretary called the roll and SR 3 was adopted on the following vote: Three senators voted "Yes", one voted "No", and one abstained. Therefore, SR 3 came out of committee with the recommendation that it BE ADOPTED.

There being no further business before the committee at this time, the committee adjourned.
