MINUTES OF MEETING OF THE SENATE RULES COMMITTEE FEBRUARY 17, 1983

The sixth meeting of the Senate Rules Committee was called to order by Chairman Frank W. Hazelbaker, at 6:30 P.M. on February 17, 1983, in Room 331 of the Capitol Building. All members were present.

The meeting was called for the purpose of discussing transmittal of House Bills as requested by Speaker Daniel Kemmis of the House.

In a letter dated February 17, 1983, Speaker Kemmis listed several bills which he wished the Senate to treat as appropriation or revenue measures, in order that they would not be subject to the 45th day transmittal rule.

After discussion by the members of the committee, Senator Jean Turnage moved that the request of the House contained in the Speaker's letter of February 17, 1983 relating to the following bills:

HB 23, HB 326, HB 392, HB 418, HB 471, HB 476 and HB 600

as being considered for the purpose of the rules as appropriation bills, be granted, and that the following bills:

HB 613, HB 682 and HB 767

be considered revenue bills. This action taken shall not constitute a precedent as to the definition of appropriation or revenue bills. Further, that the House be required to send the bill containing the schedule for the Foundation Program over to the Senate by the 45th day.

The motion passed unanimously.

There being no further business, the meeting adjourned at 6:45 P.M.

- FROM: Representative Daniel Kemmis, Speaker of the House
- RE: Transmittal of Bills

At your request, I am attaching a list of bills which the House needs to consider in conjunction with the general appropriation process. If it is necessary to transmit these bills now, it will result in exactly the kind of fragmentation of the appropriation process that we have tried very hard to avoid.

To accomodate the Senate, we will act immediately on eight bills which have been re-referred to the Appropriations Committee from other committees. The Appropriations Committee will hold a hearing tonight on four bills and another hearing on Sunday on nine more bills. We would then ask the Senate to classify as appropriations bills:

HB 23	This bill would provide an ad hoc cost of

HB 326 This would remove the 50% restriction on the (Bergene) amount of state funds that can be appropriated for regional mental health service contracts. Finally, there are three bills now being considered by appropriations subcommittees which are more in the nature of revenue bills. All three seek to reduce the need for general fund appropriations by imposing certain fees. These bills are very much a part of the planning being done by the subcommittees as they structure their budgets. The bills are:

Requiring deposit of subdivision fees in HB 613 (Lory) the state general fund. HB 682 Establishing a fee for an ambulence license commensurate with the cost of licensing. (Appropriations Com.) HB 767 Revising fees for health care facilities.
