After discussion by committee members, it was decided that SB 451 should be put on the floor of the Senate for debate.


Senator McCallum moved that SB 451 DO PASS. Senator Graham and Senator Mazurek both voted "No". Motion carried on a vote of 3-2.

CONSIDERATION OF SENATE JOINT RESOLUTION NO. 12: Office Space for Each Legislator.
