ROLL CALL: All members of the Committee were present.


PURPOSE OF THE MEETING:

Myron K. Strand - Strand was born in Plentywood and raised on a farm near Reserve. He graduated from Medicine Lake High School in 1948, and received his bachelor of science degree in Agricultural Economics from Montana State University in 1952. He served in the U.S. Army from 1952 to 1964 and the National Guard from 1965 to 1979. Strand is the owner/operator of Strand Aviation of Kalispell, a flight school and charter service he has operated since 1965.

He is a member of the Kalispell Chamber of Commerce, Rotary, and Montana Aviation Trades Association.

Strand will serve on the board as the member who is active in aviation education, and is appointed for a term ending January 1, 1987.

APPT

Terry D. Marshall - Marshall, who was born in Kalispell, is currently the president, chief executive officer and a member of the board of directors of Big Sky Airlines in Billings. He graduated from Montana State University in 1967 with a bachelor of science degree in economics and business, and in 1969 he received a master of science degree in economics from Oregon State University, Corvallis, Oregon. In 1979 Marshall joined Big Sky Airlines, Billings, as the director of market planning. He became the vice-president of planning and chief operating officer for Big Sky Airlines in 1980 before assuming his current position.

Marshall will serve on the board as the member representing inter-state commercial airline operators, and will serve a term ending January 1, 1987.

C.R. Ugrin - Ugrin represents the fixed based operators on the Aeronautics Board. He is currently the owner/manager of Miles City Aero Service, Inc. and has served as the Miles City Airport Manager since 1950. Ugrin is a member and past president of the Montana Aviation Trades Association and is also a member of the Montana Pilot Association and the Montana Airport Management Association.

He will serve a term ending January 1, 1987.

DEPARTMENT OF AGRICULTURE

As Director of the Department of Agriculture.

APPT Keith Kelly - Kelly is the immediate past deputy director of the Department of Agriculture. He has served as chairman of the Governor's Ad Hoc Committee on Agriculture since 1976. From 1974 to 1976, Kelly worked in Washington, D.C. for Western Wheat Associates, an international wheat market development organization. Kelly earned a bachelor of science degree from Montana State University (MSU) in agricultural business in 1968, and a master of science degree in agricultural economics from MSU in 1973. He served in Vietnam from 1969-1970 with the 101st Airborne Division of the U.S. Army.

Kelly's appointment is effective January 8, 1983, and he will serve at the pleasure of the Governor.

AS MEMBERS OF THE BOARD OF ARCHITECTS

APPT Jerrell D. Ballas - Ballas was raised in Missoula and attended Montana State University where he received his B.S. in architecture in 1968. He served in the U.S. Army Corps of Engineers from 1969-1971. In 1974 he became an associate architect with the firm of Fox, Ballas, Barrow and Associates, and two years later he became a partner. Ballas is a member of the American Institute of Architects; the Missoula Society of Architects; the Construction Specifications Institute; and the Montana Technical Council.

He is one of two registered architects on the board, and his term will expire March 27, 1985.

re-APPT Bonita Blewett Donohue - Donohue, a Montana native, graduated from Helena Senior High in 1959. She was traffic manager for Kaiser Cement and Gypsum during the early 1960's. In 1964 she was executive secretary for KRTV television. Presently, Donohue and her husband, Allen, are part-owners of the Heritage Inn in Great Falls, where she serves as head of the Commercial Design Department. She is also vice-president of KMON radio in Great Falls.

Donhue has been re-appointed as a public member on the board and will serve a term ending July 1, 1985.

AS MEMBERS OF THE STATE BANKING BOARD

re-APPT Joe M. Taylor - Taylor was born and raised in Fort Scott, Kansas. He graduated from Kansas State College with a B.S. in psychology. In 1955 Taylor moved to Great Falls, and within 3 years he purchased automobile dealerships in Augusta and Sidney, Montana. He is currently owner of T & W Chevrolet in Missoula; Northern Leasing Co; Hertz Rent-a-Car in Missoula; Bitterroot Toyota, Sportland, and J & M Investments all of Missoula. Taylor is a member of the Missoula Chamber of Commerce Board of Directors and is Co-Founder, President and Chairman of the Board of the Missoula YMCA.

Taylor serves as a public member on the board and will serve a term ending July 1, 1985.

APPT Earl W. Johnson - Johnson was born and raised in Lewistown and received a B.S. in industrial engineering from Montana State University in Bozeman. He was vice-president of First Bank in Lewistown from 1952-1969; vice-president of First Bank, Fargo, North Dakota from 1969-1972; and president of First Bank Southside in Missoula from 1972-1977. Johnson has been president of First Bank Helena since 1977. He is the director of the American Banking Association (ABA) Communications Council and of the ABA Advertising Committee. He is also the director of the Montana Banker's Association Board of Directors.

Johnson will serve on the board as an active officer of a national bank in Montana and will serve a term ending July 1, 1985.

APPT John C. Witte - Witte is a graduate of the Wisconsin School of Banking and the Senior Bank Officer's School of Banking at Harvard University. He joined Traders State Bank in Poplar in 1963 and served as president of the bank for 11 years. He is currently chairman of the board and executive vice-president of Traders State Bank. In 1974, Witte opened the First Citizen's Bank in Miles City and is currently chairman of the board. Witte is a past president of the Montana Independent Banker's Association and has served two terms as director of the Montana Banker's Association.

He will serve on the board as an active officer of a state bank and his term will expire July 1, 1985.

APPT D.E. Olsson - Olsson is the President of the Ronan State Bank. He is a graduate of the University of Montana Law School. Olsson was a member of the Helena branch of the Federal Reserve Board from 1974 through 1977, and was appointed to the Governmental Relations Council of the American Banker's Association from 1977 to 1980.

Olsson fulfills the board requirement of being one of two active officers of a state bank and is re-appointed for a term ending July 1, 1984.

APPT John S. Cote - Cote was born and raised in Butte. He is a graduate of Butte Central High School, George Washington University, and Princeton University. Cote is currently the general manager for the Butte General Office of New York Life Insurance Co. He is a co-owner of Butte Glass Co., Christie Transfer and Storage, Country Club Estates, and Butte East, Inc. He is a member of the Butte Chamber of Commerce, Butte Central Athletic Association, St. James Community Hospital Board, United Way Board, and the Butte Local Development Board.

Cote fulfills the board requirement of being one of three public members and is appointed for a term ending July 1, 1984.

AS MEMBERS OF THE BOARD OF BARBERS

APPT Eugene J. Thomas - Thomas, a native of Anaconda, graduated from Anaconda Central High School. In 1963, he entered Molar Barber College in Spokane. After completing barber school, Thomas worked at the Turf Barbership in Anaconda, which he later purchased. Thomas is now serving a second term as president of the Anaconda Kiwanis Club. He has also served as president, vice-president, and recording secretary of Local 575 Barber's Union.

He will serve as one of three barbers on the board, and his term will expire July 1, 1985.

APPT Ed C. Johnston - Johnston, a native of Anaconda, graduated from Anaconda High School in 1949. He served as a fireman in the Anaconda Fire Department for 20 years and eventually became Fire Chief. Johnston was a member of the City-County Planning Board for five years and a lobbyist for the Montana Fire Fighters Association for 12 years. He is retired now and resides in Helena.

Johnston will serve as a public member on the board, and his term will expire October 7, 1984.

3 yr term AS MEMBERS OF THE BOARD OF CHIROPRACTORS

APPT Rudolph G. Glatz- Glatz attended Lincoln Business College in Denver, Colorado. Upon graduation he served as a printer's apprentice with the Brighton Register in Brighton, Colorado. He has been a printer for 52 years and has been publisher of the Winnett Times in Winnett, Montana for over 36 years. Glatz is a member of the Masonic Order, Shrine, Eagles, and Order of Eastern Star.

He will serve as a public member on the board, and his term will expire October 6, 1984.

RE-APPT Dr. Carroll E. Albert- Dr. Albert is a graduate of Great Falls High School and Western States Chiropractic College. He returned to do graduate work in 1947 and has been a practicing chiropractor for 35 years in Great Falls. Dr. Albert is a member of both the Montana Chiropractic Association and the American Chiropractic Association. He is active in the Elks and the Loyal Order of Moose as well as the Jaycees and the Optimists Club.

He will serve as one of three practicing chiropractors on the board and will serve a term ending January 9, 1985.

APPT Dr. W. Pat Pardis - Dr. Pardis attended the University of Montana majoring in political science and received his bachelor's degree in 1973 from the University of Texas, Austin, Texas. In 1980 he received his Doctorate of Chiropractic from Palmer College of Chiropractic, Davenport, Iowa. He is a member of the International Chiropractic Association, and the American Chiropractic Association's ethics committee. Pardis is currently the owner and operator of Pardis Chiropractic Clinic in Shelby.

He will serve a term ending January 9, 1986.

APPT Monty E. Long - Long, a Kalispell native, is currently the Flathead County Assessor, a position he has held since 1976. He attended Northern Montana College, entered the United States Army in 1967, and was honorably discharged in 1970. He is a member of the Kalispell Jaycees, the Flathead Search and Rescue Association, the United Way, the Flathead March of Dimes and the Kalispell Lions Club.

He will serve a term ending January 1, 1987.

APPT Paul H. Palm - Palm was born in Glasgow and graduated in 1963 from Hinsdale High School. He is currently the director of programs for school districts 1 and 17H in Hardin. He received a bachelor's degree in 1967 and a master's degree in 1970 both from Montana State University. Palm is Montana's representative for the National Association of Administrators of State and Federal Education Programs; chairman of the Big Horn County Board of Health, and a member of the Hardin Chamber of Commerce and the Kiwanis Club.

He will serve on the board as a member with educational expertise, a member residing in a coal impact area and will serve a term ending January 1, 1987.

APPT Dale Tash - Tash was born in Butte and graduated in 1943 from Beaverhead County High School. He served in the U.S. Air Force from 1943-46 and was honorably discharged. He received a bachelor's degree from Western Montana College in 1950, a master's degree from the University of Montana in 1951 and an advanced degree in educational administration from Montana State University in 1967. Tash was a professor of history and an academic dean at Western Montana College from 1951-81 and served as acting president of Western from 1978-79. He is currently semi-retired and serves as a special assistant to the president of Western.

He will serve on the board as a member with educational expertise, and will serve a term ending January 1, 1987.

Mike Greely - Attorney General Mike Greely is a native Montanan, graduate of Yale University, and received his law degree from the University of Montana Law School. Greely was elected to the Montana House of Representatives in 1971 and served three legislative sessions. In 1975 he was elected to serve in the Montana Senate. In 1976 Greely was elected to the Office of the Attorney General, and was re-elected to the same position in 1980.

He will serve a term ending January 1, 1987.

Jeremiah F. Johnson - Johnson graduated from Butte Public High School in 1962. He attended the Montana School of Mines in Butte from 1962-1964, graduated from the University of Montana in 1966 with a bachelor's degree in history and in 1974 received a master's degree in sociology from the University of Montana. Johnson has served as a member on several councils including the Governor's Crime Control Commission - Juvenile Delinquency Task Force in 1971 and 1972, the Governor's Juvenile Justice Advisory Council in 1972 and 1973, the Juvenile Probation Officers Association from 1972 to 1981, the Youth Justice Advisory Council from 1976 to 1979 and chairman of the legislative committee of the Montana Correctional Association from 1972 to 1974.

He will serve a term ending January 1, 1987.

Michael Abley - Abley, a graduate of Billings Central High School, received his bachelor of arts degree in sociology from Carroll College, Helena, and did postgraduate studies in the administration of justice at the University of Southern Illinois, Carbondale. He has been employed as a law enforcement training officer for the Greater Egypt Regional Planning and Development Commission of Carbondale, Illinois, court coordinator for the Montana Justice Project of the Montana Board of Crime Control and is currently the court administrator for the Montana Supreme Court.

He will serve a term ending January 1, 1987.

Frank W. Hazelbaker - Senator Hazelbaker, who was born and raised in Dillon, was educated at the University of Montana. He served in the Montana House of Representatives from Missoula County in the 1941, 1943 and 1945 legislative sessions and from Beaverhead County during 1961 and 1963. He has been elected from Beaverhead County to the Montana Senate since 1967. Hazelbaker served as the Senate minority leader in 1975 and is the Senator majority leader for the 1983 legislative session.

He will serve a term ending January 1, 1987.

Carle F. O'Neil - O'Neil, a native of Kalispell, graduated from Flathead County High School in 1939. He received a bachelor's degree in history and political science from Carleton College, Northfield, Minnesota, in 1943 and a master's degree in political science from Montana State University in 1948. He received an advanced degree in social work from the University of California, Berkeley, in 1956. O'Neil served in the U.S. Navy from 1942 to 1946 and in the U.S. Naval Reserve from 1946 to 1955. In 1949 he was elected from Flathead County to serve one term in the Montana House of Representatives. O'Neil currently is vice-president of Western Building Centers, Kalispell, and has served as chairman of the Montana Juvenile Justice Advisory Council since 1976.

He will serve a term ending January 1, 1987.

Donald R. Peoples - Peoples was born and raised in Butte. He graduated from Montana State University in 1962 with a bachelor's degree in education, and did graduate work at Western Montana College, Montana State University, the University of Michigan and Pacific Lutheran University, Tacoma, Washington. Peoples was the director of public works from 1970-77 for model cities and community development, Butte-Silver Bow public works director from 1977-79 and has been chief executive of Butte-Silver Bow since 1979. He is currently the president of the Montana League of Cities and Towns, a member of the board of directors of the National League of Cities and chairman of the Northwest Power Planning Advisory Council.

He will serve a term ending January 1, 1987.

AS MEMBERS OF THE BOARD OF DENTISTRY

APPT Elmer N. Cox - Cox, a native of Fort Benton, attended Fort Benton High School and later served six years in the United States Navy as an Aviation Chief Machinist Mate. In 1947, Cox returned to Fort Benton where he farmed until 1973 when he moved to Great Falls and opened Elmer's Realty.

Cox has been appointed as a public member to fulfill a new requirement that one of the seven members of the board represent the general public. He will serve a term ending January 4, 1987.

Dr. Byron J. Greany, D.D.S. - Dr. Greany graduated in 1949 from the University of Minnesota Dental School. He served in the U.S. Army Dental Corps from 1949 until 1953, when he began a private dental practice,

APPT which he is still operating in Anaconda. Dr. Greany is a member of the Knights of Columbus, Elks, American Legion, Montana Dental Association, and the American Dental Association. He has served on the Board of Directors of the Anaconda Community Hospital since 1968, and he is currently president of the Montana Dental Association.

Dr. Greany will serve as one of five licensed dentists on the board, and his term will expire March 29, 1987.

Edgar Justesen - Justesen was born and raised in Beach, North Dakota and is a graduate of Beach High School. He is currently the electric superintendent for the Montana-Dakota Utilities Co. He has worked 32 years for the company and has held positions in Beach, N. D., Baker and Glendive. While living in Baker he served three terms on the local school board. Justesen has been a member of the American Legion for 30 years.

He will serve on the board as one of two public members, and his term will expire July 1, 1987.

Jerry L. Painter - Painter is a native of Great Falls. He attended the University of Puget Sound, receiving a B.S. degree in 1971. In 1974, he graduated from the University of Montana Law School, and since that time has been a practicing attorney in Great Falls. Painter is a member of the State Bar Association of Montana and the American Bar Association.

He serves as the public member on the board, and his term will expire July 1, 1986.

YEAPPT Spencer S. Hegstad - Hegstad was born and raised in Butte. He graduated from Butte High School and later attended Western Montana College. He is a member of the Dillon Volunteer Fire Department, Dillon Jaycees and the Benevolent Protective Order of Elks. Hegstad is currently the owner and manager of the Dillon Sears Catalog Store. He has served on the Fish and Game Commission since 1976.

He will serve a term ending January 1, 1987.

APPT Robert A. Jensen - Jensen was born and raised in Circle, and graduated from Circle High School in 1961. He is currently serving his fifth term as Sheriff of McCone County, a position he was first elected to in 1966. Jensen is a member and past director of the Montana Sheriffs and Peace Officers Association. He is an avid hunter and fisherman, and is a member of the National Rifle Association and the Circle Rifle Club. Jensen is also the owner and operator of a farm and ranch east of Circle.

He will serve a term ending January 1, 1987.

AS MEMBERS OF THE HARD-ROCK MINING IMPACT BOARD

James E. Edwards - Edwards, a native of Anaconda, is a former Anaconda Company smelter worker. He has been a co-owner of the Embassy Club west of Anaconda since 1968 and was elected as a Deer Lodge County Commissioner in 1981. He fulfills the requirement that one elected county commissioner must serve on the board. Edwards is also one of three members who must reside in an area impacted by large scale mineral development.

He will serve a term ending January 7, 1985.

Leonard H. McKinney - McKinney, a Helena native, received his B.A. degree in economics and business administration from Whitman College in Walla Walla, Washington. He graduated from the University of Montana Law School in 1957. He is a member of the Montana Bar Association and resides in Lewistown, where he has practiced law since 1961.

McKinney will serve as the public member of the board. His term will expire January 7, 1985.

Koehler S. Stout - Stout was raised in Helmville. He attended the Montana College of Mineral Science and Technology, where he received his B.S. degree in mining engineering in 1948 and his M.S. degree in geological engineering in 1949. Stout is a member of the American Society for Engineering Education, the National Society of Professional Engineers, and is a past president of the Montana Mining Association. Stout has taught engineering science at the Montana College of Mineral Science and Technology in Butte since 1952.

He will serve on the board as a representative of a hard-rock mining industry. His term will expire January 1, 1987.

Duane D. Friez - Friez will serve on the board as a representative of a major financial institution. He is currently president of the First Fidelity Bank in Glendive, an institution that he founded in 1979. Friez began his banking career with the First National Bank of the Black Hills in Newell, South Dakota. He graduated from the Wisconsin Graduate School of Banking in 1968. Friez continued to work with the First National Bank of the Black

Hills until 1976, when he helped organize the Treasure State Bank in Glasgow, Montana. From 1954 until 1960, he owned and operated a grain farm in Adams County, North Dakota.

He will serve a term ending January 7, 1985.

James A. Tulley - Tulley is currently the Big Timber city attorney and a past president of the Big Timber Chamber of Commerce. He received his law degree in 1974 from Washington University Law School of St. Louis and has practiced law in Big Timber since then. He is a member of the Montana Bar Association and the American Bar Association. Tulley has served on the local school board for the past five years.

He fulfills the requirement that one elected school trustee must serve on the board. His term will expire January 1, 1987.

APPT J. Howard Toole - Toole, a Missoula native, graduated in 1967 with a bachelor of arts in foreign languages from Lawrence University, Appleton, Wisconsin, and received his law degree from the University of Montana Law School in 1978. He served as the deputy city attorney for Missoula from 1978 to 1982. In 1982 he began a private law practice in Missoula. Toole is a member of the State Bar of Montana, the American Bar Association, the Missoula Housing Authority Board of Commissioners and the City of Missoula Open Space Advisory Committee.

Toole will serve as one of the three public members on the board, and is appointed to serve a term ending January 1, 1987.

YEAPPT William A. Spoja - Spoja, a Lewistown native, graduated in 1952 with a bachelor of arts degree from the College of Great Falls and received his law degree in 1969 from the University of Montana Law School. He served as the Fergus County Attorney from 1969 to 1982, and is currently operating a private law practice in Lewistown. Spoja is a member of the PHI DELTA PHI legal fraternity, the Fraternal Order of Eagles, the Elks Club, Rotary and the Lewistown Planning Board.

He is reappointed to serve as the attorney member on the board, and will serve a term ending January 1, 1987.

YEAPPT Dr. John F. McGregor - Dr. McGregor, a Great Falls native, graduated from the University of Iowa College of Medicine and was licensed to practice in the state of Montana in 1940. He served as an Air Force flight surgeon from 1941 to 1946 and was honorably discharged with the rank of lieutenant colonel. In 1946 he returned to Great Falls and began his medical practice, which he is still operating.
