MINUTES OF THE MEETING BUSINESS AND INDUSTRY COMMITTEE MONTANA STATE SENATE

March 22, 1983

The Business and Industry Committee met in Executive Session on March 22, 1983, at 6:05 p.m. The meeting was called to order by Chairman Allen Kolstad in Room 405, State Capitol.

ROLL CALL: All members of the Committee were present.

ACTION ON HOUSE BILL 100: Senator Dover made the motion that on page 4, line 24 through line 1 on page 5, strike subsection 5 in its entirety. Senator Lee seconded the motion.

The Committee voted 7-3 with Senators Regan, Christiaens and Fuller voting no, that the proposed amendment to HOUSE BILL 100 BE ADOPTED.

Senator Dover made the motion that on page 4, line 19, following "environment" strike remainder of line 19 through "production" on line 20. Senator Lee seconded the motion.

The Committee voted 7-3 with Senators Regan, Christiaens and Fuller voting no, that the proposed amendment to HOUSE BILL 100 BE ADOPTED.

Senator Dover made the motion that on page 2, line 11, following "is" strike remainder of line 11 through "as" on line 12 and insert "at" and on page 2, line 12, following "minimum" insert "in". Senator Lee seconded the motion.

The Committee voted 7-3 with Senator Regan, Christiaens and Fuller voting no, that the proposed amendments to HOUSE BILL 100 BE ADOPTED.

Senator Dover made the motion that on page 2, line 18, following "union" strike remainder of line 18 in its entirety and insert "or" and on page 2, line 19, following "development" strike remainder of line 19 through "banking company" and insert "corporation created pursuant to Title 32, Chapter 4". Senator Lee seconded the motion.

The Committee voted unanimously, by voice vote, that the proposed amendments to HOUSE BILL 100 BE ADOPTED.

Senator Dover made the motion that on page 10, line 14, following "accountability" strike remainder of line 14 through "PUBLIC" on line 16 and insert the previous language. Senator Lee seconded the motion.

The Committee voted 8-2 with Senators Fuller and Christiaens voting no that the proposed amendments to HOUSE BILL 100 BE ADOPTED.

Senator Dover made the motion that on page 4, line 10, following "made" insert "when sufficient funds are not available to fund all possible investments", strike "shall" and insert "may". Senator Lee seconded the motion.

The Committee voted 9-1 with Senator Regan voting no that the proposed amendments to HOUSE BILL 100 BE ADOPTED.

ACTION ON HOUSE BILL 464: Senator Dover made the motion that House Bill 464 Be Concurred In. Senator Lee seconded the motion.

Senator Goodover made a substitute motion that House Bill 464 Be Not Concurred In. Senator Regan seconded the motion.

The Committee voted, by Roll Call Vote, 6-4, with Senators Dover, Fuller, Gage and Kolstad voting no that HOUSE BILL 464 BE NOT CONCURRED IN.

Senator Regan will carry this bill on the floor.

ACTION ON HOUSE BILL 685: Senator Fuller made the motion that on page 6, line 14, strike "March" and insert "January". Senator Lee seconded the motion.

The Committee voted unanimously, by voice vote, that the proposed amendment to HOUSE BILL 685 BE ADOPTED.

Senator Goodover made the motion that on page 4, line 2, following "businesses" strike remainder of line 2 through "are" on line 3 and on page 4, line 3, following "Montana" strike remainder of line 3 through "Montana" on line 4. Senator Lee seconded the motion.

The Committee voted unanimously, by voice vote, that the proposed amendments to HOUSE BILL 685 BE ADOPTED.

Senator Dover made the motion that on page 16, line 12, following "11" insert "and 16 and 17". Senator Fuller seconded the motion.

The Committee voted 8-2 with Senators Fuller and Kolstad voting no that the proposed amendments to HOUSE BILL 700 BE ADOPTED.

Senator Dover made the motion that House Bill 700 As Amended Be Concurred In. Senator Christiaens seconded the motion.

The Committee voted 9-1 with Senator Boylan voting no that HOUSE BILL 700 AS AMENDED BE CONCURRED IN.

Senator Mazurek will carry this bill on the floor.

ACTION ON HOUSE BILL 818: Senator Goodover made the motion that House Bill 818 Be Concurred In. Senator Fuller seconded the motion.

The Committee voted, by Roll Call Vote, 5-5 so the motion failed. The bill will stay in committee.

ACTION ON HOUSE JOINT RESOLUTION 11: Senator Dover made the motion that House Joint Resolution 11 Be Not Concurred In. Senator Gage seconded the motion.

The Committee voted, by Roll Call Vote, 7-3 with Senators Christiaens, Fuller and Regan voting no that HOUSE JOINT RESOLUTION 11 BE NOT CONCURRED IN.

Senator Gage will carry this bill on the floor.
