

MINUTES OF THE MEETING
LEGISLATIVE ADMINISTRATION COMMITTEE
MONTANA STATE SENATE

March 24, 1983

The twelfth meeting of the Legislative Administration Committee was called to order by Senator Kolstad, Chairman, at 11 a.m. on the above date in Room 415 of the Capitol Building.

ROLL CALL: All members were present except Senator Mazurek who was excused.

CONSIDERATION OF SENATE RESOLUTION NO. 5: Senator Kolstad placed the resolution before the committee and asked for proponents of the resolution.

PROPOSERS: Senator Stephens, District 4, appeared before the committee and explained that this bill is honoring the First Special Service Force for its sacrifices and accomplishments during World War II and supporting the placement of a memorial during the celebration of the 40th anniversary of the allied liberation of Rome. We have a gentleman here from the First Special Service Force who would like to speak on this resolution.


Bob Durkee, First Special Service Force, said this bill would commemorate the 40th anniversary of the First Special Service Force. This is an organization of veterans of a Canadian and American army unit of World War II. The tablet will memorialize that the Force led the way in the attack to liberate Rome on June 4, 1944 and will be dedicated to our men who died in this event. There were 1,500 men in this unit and 500 were killed in action. The dedication will take place during the national celebration of the 40th anniversary of the city's liberation in 1984. Mr. Durkee offered an amendment that would change "partisans" to "valiant Italian resistance" on page 1, line 22. The Italian government asked for this amendment.

Being no further proponents or opponents, a motion was made by Senator McCallum to amend Senate Resolution 5 page 1, line 22 following "and" strike "partisans" insert "valiant Italian resistance." Motion carried.

ACTION-SENATE RESOLUTION 5: Senator McCallum made a motion that S. R. 5 as amended BE ADOPTED. Motion carried.

There being no further business before the committee at this time the meeting adjourned at 11:10 a. m.
