MINUTES OF MEETING LOCAL GOVERNMENT COMMITTEE MONTANA STATE SENATE

April 18, 1983

The meeting of the Local Government Committee was called to order by Chairman George McCallum at 10:30 a.m. in Room 402 of the State Capitol.

ROLL CALL: Eight Senators were present with Sens. Conover, Boylan and Van Valkenburg being excused.

FURTHER CONSIDERATION OF HOUSE BILL NO. 171: Sen. Marbut explained that this bill had gone out of the committee and he had had an objection at that time. The bill had been resurrected for reconsideration and was back in the committee. He had a proposed amendment which he presented to the committee and explained them. On page 2, line 20, the workd "may" would be changed to "shall". On page 2, line 21, his amendment would provide that if a protest petition signed by a majority of the landowners of the area was presented at the hearing, the annexation would be disapproved. His purpose in the amendments would be to keep the county commissioners out of the annexation process for fire districts. This would prevent the large landowner being annexed against his wishes and making him pay for it.
