HOUSE BILL NO. 148

This bill requires a statement of intent because the training program required in section 1, amending 80-8-209(5), must be administered according to rules to be promulgated by the department.

It is the intent of the legislature that the rules shall provide for training which ensures that each participant possesses the qualifications listed in 80-8-209(3). The department shall provide for a schedule of training sessions which will enable an applicant for recertification to obtain the required training either in a 1-day segment or over an extended period. In either case no applicant for recertification may be recertified unless he has received part or all of the required training within 1 year prior to the commencement of the 5-year period for which recertification is sought.
