A brief discussion ensued and Rep. Marks moved the dates be changed to the first and 18th legislative days. Seconded and passed unanimously.

Rep. Keyser moved that House Resolution 2, as amended, do pass. Passed unanimously.

Executive action was then taken on House Joint Resolution 1.

Rep. Jack K. Moore moved the section on funding MSU at 100% of its budget request be deleted from the Resolution. Rep. Keyser seconded, passed unanimously.

Rep. John Vincent moved HJR-1 do pass, as amended. Passed unanimously.
