MINUTES OF THE MEETING TAXATION COMMITTEE MONTANA STATE HOUSE OF REPRESENTATIVES

February 23, 1985

The thirty-third meeting of the Taxation Committee was called to order in room 312-1 of the state capitol building by Chairman Gerry Devlin at 7:52 a.m.

CONSIDERATION OF HOUSE BILL 884: Representative Driscoll passed out copies of proposed amendments to this bill. See Exhibit 1. He said that this bill provides that when a fiscal note is completed, a slip will come to the sponsor and the sponsor will have up to 24 hours to get any difficulties straightened out and 4 days if he wants to prepare his own fiscal note.

PROPONENTS: David Hunter, representing the Office of Budget and Program Planning, stated that the amendments make this more workable and he was in support of this bill. He informed the committee that he had spoken with Diana Dowling, Executive Director of the Legislative Council, and she agreed that the sponsors' fiscal notes could be printed in a different color.

There were no further proponents.

OPPONENTS: There were none.

QUESTIONS ON HOUSE BILL 884: There were none.

Representative Driscoll closed and the hearing on this bill was closed.
