MINUTES OF THE MEETING BUSINESS AND LABOR COMMITTEE MONTANA STATE HOUSE OF REPRESENTATIVES

February 25, 1985

The meeting of the Business and Labor Committee was called to order by Chairman Bob Pavlovich, on February 25, 1985 at 7:30 a.m. in Room 312-2 of the State Capitol.

ROLL CALL: All members were present with the exception of Representative Schultz, who was excused by the chairman.

HOUSE JOINT RESOLUTION 39: Hearing commenced on House Joint Resolution 39. Representative Red Menahan, District #67, sponsor of the bill, stated Burlington Northern has reduced its property taxes by 6 million dollars in one year and that a reduction of 4.3% in coal freight rates of Burlington Northern would cause a revenue reduction equal to the reduction of revenue to the State of Montana from a reduction in coal severance tax. We are asking Burlington Northern to do what we in Montana are doing, added Representative Menahan.

There being no proponents or opponents to the bill, the representative was excused by the chairman and the hearing on House Joint Resolution 39 was closed.

ACTION ON HOUSE JOINT RESOLUTION 39: Representative Driscoll moved DO PASS on House Joint Resolution 39. Representative Hansen seconded the motion. Representative Brandewie moved to amend on page 2, deleting lines 3 through 9 and added that we are asking the Burlington Northern to absorb our reduction. Representative Kadas explained that we are asking them not to absorb our reduction. Representative Brandewie withdrew his motion. Representative Simon asked if this resolution is necessary since Representative Winslow's resolution has passed and stated that 6 million dollars is not a tax break. Representative Bachini suggested both resolutions be sent to the senate and allow them to work these into one resolu-Representative Ellerd moved to amend on page 1, striking lines 22 through line 2 on page 2. The motion did fail with 9 members voting yes and 10 members voting Representative Kitselman moved to amend on page 2, line 4, striking easily. The motion did pass unanimously. Ouestion was called to Representative Driscoll's DO The motion received a 10 to 10 vote. PASS motion. Joint Resolution will be sent to the house floor WITHOUT RECOMMENDATION.
