# MINUTES OF THE MEETING BUSINESS AND LABOR COMMITTEE MONTANA STATE HOUSE OF REPRESENTATIVES

February 27, 1985

The meeting of the Business and Labor Committee was called to order by Chairman Bob Pavlovich on February 27, 1985 at 7:30 a.m. in Room 312-2 of the State Capitol.

ROLL CALL: All members were present with the exception of Representative Ellerd, who was excused by the chairman.

HOUSE BILL 924: Hearing commenced on House Bill 924. Representative Bob Pavlovich, District #70 introduced the bill for Representative Francis Bardanouve, District #16. Representative Bardanouve then explained that this bill resulted from a supreme court decision. Currently there are more liquor facilities on certain reservations than are allowed by quota. House Bill 924 would permit all facilities on a reservation to be licensed and no quota will exist. A license may not be removed from a reservation, added Representative Bardanouve.

Proponent John LaFaver, Director, Department of Social and Rehabilitation Services, stated that there are approximately 3 liquor establishments on reservations that do not have a state license. Prior to the supreme court decision is was not certain if a license was needed, explained Mr. LaFaver.

Representative Kitselman asked John LaFaver is a license can be transferred between reservations, to which the answer was no.

There being no further discussion by proponents and no opponents to the bill, all were excused by the chairman and the hearing on House Bill 924 was closed.

ACTION ON HOUSE BILL 924: Representative Jones moved DO PASS on House Bill 942. Representative Schultz seconded the motion, which received a unanimous vote. House Bill 942 DO PASS.

ADJOURN: There being no further business before the committee, the meeting was adjourned at 7:50 a.m.
