MINUTES OF THE MEETING BUSINESS AND LABOR COMMITTEE MONTANA STATE HOUSE OF REPRESENTATIVES

March 28, 1985

The meeting of the Business and Labor Committee was called to order by Chairman Bob Pavlovich on March 28, 1985 at 8:00 a.m. in Room 312-2 of the State Capitol.

ROLL CALL: All members were present.

SENATE BILL 350: Hearing commenced on Senate Bill 350. Senator Bruce Crippen, District #45, sponsor of the bill, explained this provides for imposition of fines when the Securities Act has been violated and after suspension of a license. A \$500 per violation fine is included.

Proponent Kim Schulke, Staff Attorney, Office of the State Auditor, Securities Department, explained this will give the department the opportunity to recoup some of their expenses spent investigating.

Representative Schultz asked Kim Schulke what recourse the purchaser may have. Ms. Schulke explained the department may issue an order to get the purchasers money returned.

There being no further discussion by proponents and no opponents, all were excused by the chairman and the hearing on Senate Bill 350 was closed.

ACTION ON SENATE BILL 350: Representative Kitselman moved DO PASS on Senate Bill 350. Second was received, Senate Bill 350 will BE CONCURRED IN by unanimous vote.

ACTION ON SENATE BILL 129: Representative Howe stated the subcommittee did meet and were waiting to hear Senate Joint Resolution 31. Representative Driscoll moved to amend on the statement of intent, line 23, and explained the financial statement should be enough. Representative Bachini added that the clerk and recorders are against the bill due to the loss of money and the fee must be adjusted to make this work. Representative Bachini moved DO NOT PASS on Senate Bill 129. Representative Brandewie stated this is not a clerk and recorder bill and that they did get a raise in filing fees this session. Representative Ellerd offered a substitute motion that Senate Bill 129 DO PASS and moved the amendments attached hereto as Exhibit 1 and 2. He added there is no protection Business and Labor March 28, 1985 Page 2

for farmers, this bill is for grain people and lending institutions. Representative Howe stated that on the first amendment, you can not segregate livestock from a lien. Representative Schultz added that there is no way sheep and hogs can be identified and that a banker will not loan on anything that is not branded and less than 1/2 of 1 percent of all cattle are unbranded. Representative Thomas explained that it is possible to mortgage unbranded cattle. Representative Keller offered his support of the first amendment. Ouestion being called to the amendments moved by Representative Ellerd, the first amendment received 9 yes votes and ll no votes. A voice vote defeated the second set of amendments. Representative Ellerd withdrew his DO PASS Representative Bachinis DO NOT PASS motion motion. received 9 yes votes and 11 no votes. Representative Driscolls amendment received a unanimous vote. Representative Brandewie moved DO PASS AS AMENDED. A roll call vote resulted in 11 members voting yes and 9 members voting no. Senate Bill 129 will BE CONCURRED IN AS AMENDED.

ACTION ON SENATE BILL 349: Representative Kadas moved DO PASS On Senate Bill 349 and moved to strike the amendment that was put on previously and moved the amendment as shown on Exhibit 3 attached hereto. Α unanimous vote was received in favor of stripping the prior amendment. Representative Thomas stated the \$2 million dollar figure cuts out a lot of business. Representative Pavlovich did agree. Representative Simon stated this could eliminate a lot of projects that would create Montana jobs. Representative Kadas added small business' are economically and politically more stable and they are better for the state. The board is in favor of this amendment. A roll call vote resulted in 4 members voting yes and 16 members voting no. Representative Hansen moved to amend as shown on the standing committee report attached hereto. Dale Harris explained this deals with stand alone projects and is not part of the pool. The amendment did pass with Representatives Kitselman, Simon, Jones and Brandewie voting no. Senate Bill 349 will BE CONCURRED IN AS AMENDED by unanimous vote.

ACTION ON SENATE BILL 208: Representative Schultz moved DO PASS on Senate Bill 208. Representative Glaser added this puts limits on where the money may go and that this is a small handout but is better than nothing. Representative Thomas moved to amend the statement of intent, on page 3, line 4 changing the percentages to 30% and 60%. Representative Schultz did agree and stated this would help those in lower positions. The amendment did pass Business and Labor March 28, 1985 Page 3

with Representatives Hansen, Kadas and Nisbet voting no. Senate Bill 208 will BE CONCURRED IN with Representatives Ellerd, Hansen and Thomas voting no. Representative Simon moved to reconsider action on Senate Bill 208. The motion did carry with Representatives Ellerd, McCormick, Nisbet, Thomas and Glaser voting no. Representative Schultz suggested the bill be left in its original form and moved to strip all previous amendments. The motion did carry with Representatives Ellerd, Hansen and Thomas voting no. Senate Bill 208 will BE CONCURRED IN with Representatives Ellerd, Hansen and Thomas voting no.

ACTION ON SENATE BILL 399: Representative Brandewie moved DO PASS on Senate Bill 399. Representative Glaser moved the amendment proposed. The motion did fail with a voice vote being taken. Senate Bill 399 will BE CONCURRED IN with Representatives Keller, Jones, Glaser and Ellerd voting no.

ACTION ON SENATE BILL 402: Representative Driscoll moved DO PASS on Senate Bill 402. Representative Kitselman moved the amendments which did pass by unanimous vote. Senate Bill 402 will BE CONCURRED IN AS AMENDED by unanimous vote.

ACTION ON SENATE BILL 447: Representative Driscoll moved DO PASS on Senate Bill 447 and added this is a federal requirement. Second was received, Senate Bill 447 will BE CONCURRED IN by unanimous vote.

ACTION ON SENATE BILL 409: Representative Thomas moved DO PASS on Senate Bill 409. Representative Kadas moved to amend on page 3, line 19, to reinsert the stricken language as this is fairer to those injured. Representative Kadas then withdrew his motion. Senate Bill 409 will BE CONCURRED IN with all but Representative Kadas voting yes.

ACTION ON SENATE BILL 440: Representative Driscoll moved DO PASS on Senate Bill 440 and moved the amendment as proposed by the Department of Labor. Representative Thomas stated this takes away from the intent of the bill. Representative Kadas stated the department has the authority to check out self insureds and this does not fall under the title of the bill. Representative Schultz added this will effect those already insured. A voice vote defeated Representative Thomas' motion. Senate Bill 440 will BE CONCURRED IN by unanimous vote. Business and Labor March 28, 1985 Page 4

ACTION ON SENATE BILL 250: Representative Brandewie moved DO PASS on Senate Bill 250. Representative Kadas added this will allow consumers the same protection as do bonds and this will make it easier on the consumer. He then moved and explained the amendment. Representative Brandewie added this is just intended to replace the bond which is a fund of the last resort. Representative Kadas' motion received a voice vote in favor of the amendment. Representative Kadas then moved to amend on page 4, following however, striking the remainder of subsection (3). A voice vote adopted the amendment. Senate Bill 250 will BE CONCURRED IN AS AMENDED with all but Representative Thomas voting yes.

ADJOURN: There being no further business before the committee, the meeting was adjourned at 10:00 a.m.
