MINUTES OF THE MEETING LEGISLATIVE ADMINISTRATION COMMITTEE MONTANA STATE SENATE

February 25, 1985

A meeting of the Senate Legislative Administration Committee was called to order at 6:25 p.m. on February 25, 1985, by Chairman Chet Blaylock in Room 325 of the State Capitol.

ROLL CALL: Committee members Senators Chet Blaylock, Joe Mazurek, George McCallum were present.

CONSIDERATION OF SJR 25: Senator Tom Towe, principal sponsor or SJR 25, introduced the resolution to honor Senator Dave Manning. He stated that there are a couple of provisions in the whereas clauses on which he tried to work very hard to get some flavor of Dave Manning's participation in the legislature over the years, namely Senator Manning's role in the enactment of the coal severance tax, his activity in the highway program, his years as chairman of the highway committee and his very close relationship with the highway system. addition, Senator Towe stated that for 25 years the highway headquarters has remained without a name. This resolution would commend Senator Manning and express the legislature's appreciation to Senator Manning's wife by naming the Highway Building, located at 2701 Prospect Avenue in Helena, Montana, the "Dave Manning Highway Building."

PROPONENTS: Senator Cecil Weeding, on behalf of Senator Manning's abandoned senatorial district, stated he would take great pleasure in seconding Senator Towe's motion, although such an act is not the proper term. He stated he was totally and wholeheartedly in favor of everything Senator Towe said. In addition, he pointed out to the committee that Senator Manning, in his early days and throughout his career, almost literally built the cooperative electric systems in Montana. Senator Weeding did not believe this would detract from the resolution. Senator Weeding also testified that Senator Manning's career, in addition to highways, encompassed a great many other areas. Senator Weeding beleives Senator Manning is a great citizen of the state of Montana and concurred in Senator Towe's resolution.
