# MINUTES OF THE MEETING HIGHWAYS AND TRANSPORTATION COMMITTEE MONTANA STATE SENATE

March 29, 1985

The twenty-first meeting of the Highways and Transportation was called to order on March 29, 1985 at 9:40 a.m. by Chairman Lawrence G. Stimatz in Room 410 of the Capitol Building.

ROLL CALL: All members were present except Senator Tveit and Senator Weeding and Senator Shaw, whom were excused.

EXECUTIVE SESSION was called to order.

DISPOSITION OF HOUSE BILL 675: Senator Bengston moved HB 675 be TABLED. She stated she wanted this bill tabled because Mona Jamison, Attorney for the Governor, assured her that another bill, HB 419, covered the same topic as HB 675, which dealt with commemorative plates for the centennial celebration. Ms. Jamison told Senator Bengston that the two bills were not compatable, but HB 419 would have discretion to do just about anything that concerned commemorative collectors plates.

The motion carried and passed with Senator Stimatz and Senator Williams voting NO.

DISPOSITION OF HOUSE BILL 383: Senator Bengston moved HB 383 NOT BE CONCURRED IN. A roll call vote was taken and the motion passed 7-2. (SEE EXHIBIT 1) Senator Stimatz appointed himself to carry this bill on the floor.

NOTE: Senator Tveit and Senator Weeding were not present but they confirmed their votes and they are recorded on the Roll Call Vote Sheet and are included in the final vote count.
