MONTANA STATE SENATE LABOR AND EMPLOYMENT COMMITTEE MINUTES OF THE MEETING

April 17, 1985

The twenty-sixth meeting of the Senate Labor and Employment Committee was called to order by Chairman J. D. Lynch in room 331 of the State Capitol at 9:05 a.m. on April 17, 1985.

ROLL CALL: All members were present except for Senator Thomas Towe, who was excused.

FURTHER CONSIDERATION OF HOUSE BILL 375:

Senator Thayer asked Chairman Lynch if he intended to hold the Standing Committee Report on House Bill 375 until after House Bill 500 is on the floor.

Chairman Lynch replied he was going to give the report to the Secretary of the Senate and she will hand it in.

Senator Blaylock made a motion that House Bill 375 Be Concurred In.

Senator Aklestad stated that Senate Bill 247 would have a \$4 million positive impact on the employees of the State of Montana - on the average a 16% income tax and a \$16 million savings to the employees of the State of Montana. The pay plan has an impact on state employees and county employees. Senator Aklestad made a substitute motion to amend House Bill 375, put in \$6.5 million instead of \$16.5 million, saying these people will still have an actual payout.

A roll call vote was taken on Senator Aklestad's amendments to House Bill 375. The vote was 3-5; the motion failed. See attached Roll Call Vote sheet.

Senator Thayer asked Dennis Taylor if \$16.5 million would have a 2% increase the next fiscal year, 1987.

Dennis Taylor answered yes, that is right.

Senator Aklestad made a substitute motion that House Bill 375 Be Not Concurred In. On a roll call vote, the committee voted 3-5; the motion failed. See attached Roll Call Vote sheet.

Senator Haffey requested a roll call vote on the original motion that House Bill 375 Be Concurred In. The motion carried; see attached Roll Call Vote sheet.

ADJOURNMENT: The committee having no further business, adjourned at the hour of 9:40 a.m.
