

MINUTES OF THE MEETING
STATE ADMINISTRATION COMMITTEE
SECOND SPECIAL 49th LEGISLATIVE SESSION
HOUSE OF REPRESENTATIVES

March 24, 1986

The first meeting of the State Administration Committee was called to order by Chairman Walter Sales on March 24, 1986, at 3:00 p.m. in Room 317 of the State Capitol.

ROLL CALL: All members were present.

CONSIDERATION OF HOUSE BILL NO. 4: Representative Paul Pistoria, House District #36, sponsor of the bill, stated that this bill concerns the special election of new officials to implement a change in the form of local government. He said that the bill permits local governing bodies to schedule such elections at the same time as the regularly scheduled primary and general elections. This bill has an immediate effective date.


PROPOSERS: All committee members are proponents to HB 4.

There being no opponents to HB 4, Rep. Pistoria closed by saying this bill could save the state of Montana in excess of \$200,000; Cascade county alone could save in excess of \$67,000.

QUESTIONS ON HOUSE BILL NO 4: Chairman Sales asked if there were any questions from the committee. No questions were directed to Rep. Pistoria.

DISPOSITION OF HOUSE BILL NO. 4: Representative Raymond Harbin made a motion that HB 4 DO PASS. Representative Janet Moore seconded the motion. The motion CARRIED unanimously.

ADJOURNMENT: There being no further business to come before this committee, the hearing was adjourned at 3:15 p.m.
