

MINUTES OF THE MEETING
49TH LEGISLATURE THIRD SPECIAL SESSION
STATE ADMINISTRATION COMMITTEE
MONTANA STATE SENATE

June 23, 1986

The State Administration Committee meeting was called to order on the above date, in Room 331 of the State Capitol Building, at 9:07 a.m. by Chairman Haffey.

ROLL CALL: Senators Mohar, Hirsch and Conover excused for other committees, all other members present.

A quorum being present, Senator Haffey called the meeting to order.

CONSIDERATION OF HB 3: Representative Robert A. Ellerd, HD 77, chief sponsor of HB 3, said it puts legislators back to grade 8. They elected to raise it to a grade 10 for 1987. There will be an increase in salaries but it won't be as large. Grade 10 is \$17,003.00 divided by 90, or \$65.40 per day. Grade 8, in the present pay, is \$51.17 per day for an 8 hour day whether worked or not. The increase in 1987 from grade 8 increases it to \$57.44. This is still an increase of \$6.27 for grade 8. He said he feels it is the way to go because some people are going to get hurt badly with the cuts. If the pay freeze goes on, legislators will be frozen at \$57.17.

PROPONENTS: None.

OPPONENTS: None.

COMMITTEE QUESTIONS: Regarding Senator Tveit's question regarding the amount, Representative Ellerd answered that the legislators are at \$65.40 per day. That was what the pay increase was.

DISPOSITION OF HB 3: Senator Lynch moved HB 3 BE CONCURRED IN. Seconded by Senators Tveit and Harding. Motion carried. Senator Haffey asked to be recorded as voting No. Senator Boylan will carry the bill on the Senate floor.

There being no further business, the meeting adjourned.
