MINUTES OF THE MEETING APPROPRIATIONS COMMITTEE 49TH LEGISLATURE SPECIAL SESSION III HOUSE OF REPRESENTATIVES

June 28, 1986

The meeting of the Appropriations Committee was called to order by Vice-chairman, Gene Donaldson, on Saturday, June 28, 1986 at 3:05 p.m. in Room 312-3.

CONSIDERATION OF SJR 1: A JOINT RESOLUTION REQUESTING THE BOARD OF REGENTS TO PREPARE A REPORT ON THE LONG-TERM DIRECTION OF HIGHER EDUCATIONAL INSTITUTIONS IN MONTANA.

Senator Jack Haffey, Senate District 33, one of the sponsors of SJR 1, said that this bill reinforces what the Board of Regents has sought to do in terms of studying higher education. The bill asks the Board of Regents to study specific items. The main objective is to focus on efficiencies and effectiveness.

PROPONENTS: Carrol Krause, Commissioner of Higher Education, said that he hopes the legislature will look at long-term funding goals for the university system.

There were no further proponents nor any opponents, and the committee was opened to questions.

In response to a question asked by Rep. Connelly, Mr. Krause said the study will include the community colleges even though it is not specifically addressed in the bill.

There being no further questions, the hearing closed on SJR 1.

ACTION ON SJR 1: Rep. Rehberg moved that SJR 1 BE CONCURRED $\overline{\text{IN}}$. The motion was seconded by Rep. Spaeth. The question was called and the motion $\overline{\text{CARRIED}}$ unanimously on a voice vote.

ADJOURN: There being no further business, the meeting adjourned at 3:20 p.m.
