MINUTES OF THE MEETING LOCAL GOVERNMENT COMMITTEE 50th LEGISLATIVE SESSION HOUSE OF REPRESENTATIVIES

January 8, 1987

ROLL CALL: All members present.

Chairman Norm Wallin opened the meeting at 1:00 p.m. He stated he was very pleased with the new members appointed to the Committee and all those who served on the committee last time. As there was only the one bill to be considered this day, he had decided they would discuss some of the things they wanted to work together on to make the committee run efficiently and smoothly. Further, he believed we have an excellent committee, that Rep. Darko did an excellent job running it and hoped he could do as well.

There were 100 bills last time and the previous speaker said at that time this should have been a Class One committee; but don't judge this first week by what is going to happen, we will probably end up with well over 100 bills because of all the areas of government that is really hurting; at least they are screaming the loudest; you will have to realize that Local Governments seem to be hurt particularly, and he was certain there will be a lot of bills we are going to have to address, outside of taxation. For that reason, he asked that if you are sitting with two people that are new on a committee, that perhaps they would like to move right now, because the seats will be left like this and this is how the roll call will be kept, and if you move so you are between two old hands he thought it would be most helpful to do so.

Rep. Wallin introduced the secretary, Jean Stephenson and the Staff person from the Legislative Council, Lee Heiman, who has served on this committee before. The Committee will be meeting three days a week, Monday, Wednesday and Friday and it is posted 12:30 p.m.but as most of the members are on Class I committees, he felt it more appropriate to meet at 1:00 p.m. on those days which would be light so they would have a chance to at least get a snack. We will be busy most of the time right up until floor time which will be 3:30 p.m. every afternoon. The Chairman asked that if any one has a question to go through the Chair, otherwise it becomes quite a mad scramble and he will recognize that person and further, if anyone wishes to address questions to people who have testified, please go through the Chair, even if it is a follow-up question and he will give them permission, rather than go back and forth. Rep. Wallin would prefer that you do not ask each other questions until we take Executive Actionand if you wish to ask somebody who has already asked someone on the committee a question regarding a bill - let's wait until we

have excused the other witnesses and we go into Executive Session. The Chairman asked that committee members be on time, that he will start the meeting even if we do not have a quorum because we have to meet and will have a number of bills - you might have to bring a sandwich with you and he has no objection to that if you eat it while we are going thru the busy days which we are going to get. We will be fair on giving time to both sides of the bill - we will ask first for testimony from the Proponents and then we will ask for testimony from the Opponents and then we we will ask for questions from the committee; after that question period, then the sponsor of the bill will have his close. It can be done the other way but it seems to work a little better if we hold the sponsor of the bill and have all the questions on the bill before you get into a close. You are familiar with the operation of the mikes and speakers. He plans to request additional speakers. The question of smoking was addressed - the persons who smoke would sit out on the end of the table. He would hope that the persons who smoke would sit there and try and hold off until we have been in session 45 mimutes and then take a 10 minute break, and then go into session for another 45 minutes and then another break. The problem with smoking is there are signs all over the outside with NO SMOKING ALLOWED.

A collection was taken up for the coffee etc. expense from the committee members of \$2.00 per person. The matter of additional speakers was discussed and this problem will be solved by Friday's meeting.

Chairman Wallin stated that the Sponsor of HB 49 which was to be heard today is ill and unable to attend this meeting. It was his feeling that they should postpone the hearing on this bill until Friday in view of the fact that the Sponsor is unable to attend; in addition, we have only one bill on Friday to hear and there will be ample time to hear both. Rep. Gould asked if there were any witnesses for or against HB 49 present. The Chairman stated there were none on either side. Rep. Paul Pistoria made a motion that we do postpone the hearing on HB 49 until Friday at 1:30 P.M. Motion passed unanimously. It was suggested that if Rep. Rapp-Svrcek is still unable to attend that he have someone designated to move the bill for him. Chairman Wallin said he would talk to him concerning this matter.
